# The Appropriation Act, 1999

Short title.

Being an Act to provide for the services of Sierra Leone fur the year 1999.

> [1st January, 1999] Date of Commencement.

### Appropriation Act

WHEREAS it is necessary to make provision for the issue from the Consolidated Fund of sums of money to meet the expenditure to carry on the services of the Government:

1999

Now, THEREFORE, it is enacted by the President and Members of Parliament in this present Parliament assembled as follows-

This Act shall be deemed to have come into operation on the 1. 1st day of January, 1999.

The sum of two hundred and nineteen billion, seven hundred and fifty-nine million, twenty-eighty thousand and two hundred leones shall be and is hereby granted to His Excellency the President for and during the year Nineteen Hundred and Ninety-nine and the same shall be applied and expended in the manner herein described and for the several services set forth in the Schedule.

The sum of two hundred and nineteen billion, seven hundred and fifty-nine million, twenty-eighty thousand and two hundred leones referred to in section 2, shall be and is hereby declared to be charged upon and made payable from and out of the Consolidated Fund for the year Nineteen Hundred and Ninety-nine and the payment thereof shall be taken to begin and commence on and immediately after the first day of January, Nineteen Hundred and Ninety-nine.

The Accountant-General is hereby authorised and required to pay out of the Consolidated Fund for the several services specified in the Schedule, such sums as may be specified in the Warrant or Order of the Minister of Finance, Development and Economic Planning issued from time to time up to the total sum of two hundred and nineteen billion, seven hundred and fifty-nine million, twenty-eighty thousand and two hundred leones which shall come in course of payment during the year ending on the thirty-first day of December, Nineteen Hundred and Ninety-nine.

The amount from time to time paid for and in respect of the expenditure authorised in section 4 shall not exceed in the gross the sum of two hundred and nineteen billion, seven hundred and fifty-nine million, twenty-eighty thousand and two hundred leones from the first day of January, Nineteen Hundred and Ninety-nine inclusive and any balances remaining unissued at the end of December, Nineteen Hundred and Ninety nine shall lapse and not be available for making any

payment in the following year
