Excess of expenditure.

The amount from time to time paid for and in respect of the expenditure authorized in Section 4 shall not exceed in the gross the sum of four trillion seven hundred and ninety seven billion four hundred and ninety eight million two hundred and seven thousand nine hundred Leones from the first day of January, two thousand and seventeen inclusive, and any balances remaining unissued at the end of December, two thousand and seventeen shall lapse and not be available for making any payment in the following year.
