## THE CONSTITUTION OF SIERRA LEONE, 1991 (Act No. 6 of 1991)

## THE PUBLIC ELECTIONS (EARLY VOTING) REGULATIONS, 2023

Short tittle

In exercise of the powers conferred upon it by section 33 of the Constitution of Sierra Leone, 1991 (Act No. 6 of 1991) and section 171 of the Public Elections Act (Act No. 17 of 2022), the Electoral Commission hereby makes the following Regulations -

#### PART I-PRELIMINARY

1. In these Regulations, unless the context otherwise requires- Interpretation.

"Act" means the Public Elections Act, 2022 (Act No. 17 of 2022);

"Commission" means the Electoral Commission for Sierra Leone;

"early voter" means a person who is eligible to vote earlier than the day scheduled for voting;

"early voting" means voting that takes place before . the day scheduled for voting;

"early voting centre" means a centre designated by the Electoral Commission for early voting. 2. A person shall not qualify for early voting unless -

- (a) he is of either Islam or Christian faith who will be out of Sierra Leone on a pilgrimage and would be absent from Sierra Leone on the day scheduled for voting;
- (b) he is registered to be entered as an early voter under sub-regulation (b) of Regulation 4; and
- (c) his name is entered on the early voters list under Regulation 4.

Application for early voting. 3. (1) A person who wishes to be registered as an early voter shall submit an application set out in the form specified in the Schedule.

> (2) An application under sub-regulation (1) shall be made to a returning officer in the District of the applicant, not later than 7 days before the day scheduled for voting and accompanied by a declaration in writing by the applicant and such other supporting documentation as may be required by the Commission, stating or proving that the applicant is -

- (a) registered at a polling station in the District of the returning officer to whom the application is made; and
- (b) attending a pilgrimage that will prevent him from being present at the polling centre where the applicant is registered the day scheduled for polling.

Qualification for early voting.

(1) A returning officer shall, on receipt of an application Early voters 4 list under Regulation 3, -

> (a) issue the applicant, a certificate that entitles the applicant to vote on a date set aside for early voters;

- (b) enter the registration details of the applicant on the early voters list; and
- (c) enter the registration details of the applicant on the absent voters list of the polling centre where the applicant is registered.

A person shall not vote as an early voter unless that (2)person's name appears on the early voters list.

(3) A person whose name is entered on the early voters list under paragraph (b) of Regulation 4 shall vote at an early voting centre specified by the Electoral Commission under sub-regulation (2) of Regulation 5 before the day scheduled for voting as specified by the Commission.

(4) A person whose name is transferred to the early voters list shall not vote on the day scheduled for voting.

(5) A returning officer shall compile a list of registered early voters and give a copy of the list to all political parties on request.

(1) The Commission shall establish voting centres at Early voting 5. district headquarter towns to be used as early voting centres.

centres.

(2) A person qualified for early voting shall vote at a voting centre designated by the Commission under sub-regulation (1).

Elections to which early voting applies.  Early voting under these Regulations shall apply only to Presidential elections.

Manner of voting. 7. (1) Early voting elections shall be conducted in accordance with section 72 of the Act on the day scheduled for voting, with the necessary modifications.

(2) The returning officer shall ensure that at the end of the early voting session, the ballot boxes used shall be sealed in accordance with section 78 of the Act, with necessary modifications until the day scheduled for counting of ballots.

(3) Thereafter, the early voting ballots shall be transferred to the respective ballot boxes containing the normal ballots at the last station of designated counting centres.

Period of 8. The period of voting for early voters shall be between 8 am early voting. to 4 pm or as can be determined by the Commission.

Procedures 9. The Commission may develop procedures for early voting.
