NINTH REPORT OF THE COMMITTEE ON APPOINTMENTS AND THE PUBLIC SERVICE ON PARLIAMENTARY VETTING OF PRESIDENTIAL NOMINATIONS

1. INTRODUCTION

Mr. Speaker, Honourable Members, the Committee on Appointments and the Public Service met on Monday 23rd March 2015 and interviewed Seven Presidential nominees for appointment as follows:

- i. High Court Judge
- ii. National Security Coordinator
- iii. Two Members, National Commission for Privatization (NCP)
- iv. Two Board Members, Sierra Leone Roads Authority(SLRA)
- v. Board Member, Sierra Leone State Lottery

2. PROCEDURE

The Committee conducted the hearings within its set framework of procedures. The nominees were interviewed on issues pertaining to their educational background to ensure that they have the relevant education and necessary backup experience to man such important offices of state. Further probing questions put to the nominees covered wide ranging issues relating to their track

records in pertinent work situations, declared assets, tax obligations and their vision for a nationally productive tenure.

3. <u>ELEVENTH SITTING OF THE COMMITTEE ON MONSDAY 23RD MARCH 2015</u>

3:1 The following nominees were interviewed on oath:

i. Mr. Sengu Mohamed Koroma - Proposed Judge of the High Court

Mr. Sengu Mohamed Koroma is a private legal practitioner, a specialist in Corporate and Commercial Law who has acted as legal adviser to a number of corporate institutions. He had served as:

- Legal Counsel / Company Secretary and Acting Director of Administration, National Development Bank Limited 1997- 2000
- ii. Solicitor/Secretary, Director of Legal Affairs & Board Secretary, National Social Security and Insurance Trust (NASSIT) 2002-2013.

In 2013, he voluntarily resigned from NASSIT to establish a Law Firm, "Sengu Koroma & Co." 2012 to date, Mr. Sengu Koroma has been a part-time Lecturer, Department of Law, Fourah Bay College, University of Sierra Leone.

Responding to questions on what he would do about the huge back log of cases particularly in the High Court of Sierra Leone, Mr. Sengu Mohamed Koroma said that the increase in the back-log of cases is not necessarily caused by the Judiciary. The lawyers, he said, also contribute significantly in that direction. "From my experience as a Practitioner, I would say that there are two types of lawyers. Firstly, there are those professional lawyers who do not only look for remuneration but also want to make a name for themselves. Then there are those lawyers who believe that success is synonymous with wealth, so that their attention is geared towards making money at the detriment of their clients. These are the lawyers who do not go to court. They would receive money from their clients but fail to show up in court so that their matters are adjourned sine die. Once they receive another trench of payment, they would appear in court to resuscitate the matter. If lawyers regularly attend court and do so with their witnesses, the case-load will naturally be reduced. My view on the matter of adjournment is that, though it is the discretion of the judge, that discretion must be jealously guided."

ii. Mr. Ismail Sheriff Tarasid Tarawali - Proposed National Security Coordinator

Mr. Tarasid Tarawali has had a long sojourn in the Office of National Security (ONS). He joined the ONS in 2002 as an Assistant Team Leader, monitoring and Oversight Department (ONS). Through hard work, he rose through the ranks to the position of

Deputy National Security Coordinator in 2013. He is now being promoted to the position of National Security Coordinator.

Responding to questions on the participation of Members of Parliament in ONS meetings at the constituency level, Mr. Tarawali said, "I think you have a role to play. You are very important stakeholders and we expect Members to visit us and our offices nationwide, to ask questions, give information and make suggestions because you are key players within your constituencies and your role is very important in what we do as a sector. Our meetings are open to key stakeholders."

.iii. Mrs. Hasiatu Gbassa Jalloh-Agbaje — Proposed Member, National Commission for Privatization

Mrs. Jalloh-Agbaje is the Managing Director/CEO of the First International Bank (SL) Ltd.. She joined the Bank in 2006 as General Manager, Credit and Marketing (2006-2010)

Responding to questions on privatization, Mrs. Hasiatu Agbaje pledged herself to support the privatization Commission achieve its set objectives. Once her terms of reference are known, she said, she will be able to participate in all meetings and would give her honest and objective opinions in deliberations.

iv. Mr. Henry Yamba Kamara - Proposed Member, National Commission for Privatization

Mr. Henry Yamba Kamara has over 15 years' experience in Corporate Governance, Quality Management, Investment Promotion and International Trade. He was the Director of Export Development of the Sierra Leone Investment and Export Promotion agency (SLIEPA) where he rose to the position of Chief Executive Officer (Acting). Mr. Kamara is currently the Managing Director of the Sierra Leone Produce Marketing Company (SLPMC)

Answering to questions on his role as a member of the Privatization Commission, Mr. Henry Yamba Kamara said "I will do my best in ensuring that Government owned companies that are no longer viable are privatized to stop them being a liability to government.

v. Mr. Mohamed Moiwo Makaya — Proposed Board Member, Sierra Leone Roads Authority

Mr. Mohamed Moiwa Makaya is a former Member of Parliament. While in Parliament, he was a vibrant debater and an active Committee Member who served on several committees.

Answering to questions about the performance of road contractors, Mr. Makaya opined that some contractors do not give value for money. "That is one of the challenges we are going to face as a Board. I will ensure that we, the Board Members, work as a team to go after such contractors, monitor their performance to ensure that they keep to the terms of their contracts, and only approve final payments after satisfactory completion of the contracts."

vi. Dr. Lawrence R. Sesay – Proposed Board Member, Sierra Leone Roads Authority

Dr. Lawrence R. Sesay is a retired Civil Servant who served for more than ten years in the Ministry of Lands, Housing and Country Planning.

Reacting to questions about his record of Work in the Ministry of Land, Housing and Country Planning, Dr. Lawrence Sesay said, "I do not want to sing my own praises but I am sure I served the Ministry and my country to the best of my ability and that I exhibited discipline and obedience to my superiors who were the Minister and the Director."

Answering to further questions, Dr. Lawrence Sesay opined that indiscipline and disregard for the law were the root cause for non-adherence to town planning regulations and the putting up of structures in the right of way. "The laws pertaining to the Right-of Way," he said, "are there from colonial times but they are not adhered to." Dr. Sesay called on the authorities to put measures in place for the rigid enforcement of the law.

vii. Mrs. Joan S. Benya - Proposed Board Member, Sierra Leone State Lottery

Mrs. Joan Benya is a Social worker and a successful business woman with a wealth of experience in either fields of endeavour.

He has risen through the ranks to his current position as Vice President, Sierra Leone Labour Congress.

Mr. Alpha Badamasi Savage - Proposed Member, National Commission for Privatization

Answering to questions from the Committee on his input on the board as professional Engineer, Mr. Alpha Savage said "I will help in my capacity as a Member of Board to assist the National Commission or Privatization to do the right thing which includes coming out with immediate quick responses to the privatization process to address the challenges to the Ministries, Departments and Agencies

Ing. Georgette Ayomi Monica Greene - Proposed Board Member, SLRA

Responding to question from the Committee on her preparedness to serve on the board of the SLRA. Ms. Georgette Monica Green said "Am prepared to serve on the board and take any challenges that will ensue from my services".

P.C. Charles B. Caulker is a traditional ruler (1984 to date) and chairman, National Council of Paramount Chiefs. He was a Member of Parliament 1996-2007 during the course of which he served on several high profile Parliamentary Committees.

Responding to questions from the Committee on his role as an adviser to the Minister and Ministry of Mineral Resources, P.C. Caulker said "It is a very golden opportunity for me to sit on the board of the Mineral Advisory Board to give pieces of advice on mining and mineral exploration. I promise to pledge my loyalty to the job for the benefit of all Sierra Leoneans".

Mr. Victor Emmanuel Remoe Doherty – Proposed Board Member, Sierra Leone State Lottery Mr. Doherty is a businessman and Managing Director of Sabrener Security Agency. He had previously served for twenty years in the Sierra Leone Police Force where he rose to the position of Assistant Superintendent of Police.

Responding to questions from the Committee on his input on the Board, Mr. Victor Doherty said 'I do hope and trust that when I should have gone through Parliament and am finally at State Lottery, I will bring to bear on the activities of Sierra Leone State Lottery sanity, focus so that the State Lottery could become an enviable institution ha we all used to know for now. It is between life and death and if his House approve of me to ensure that the institution comes in full operation base so that the StateLottery can provide the much needed revenue that this country needs in its development strides.

Mr. Davidson Aloysius Kuyateh – Proposed member NCP

Mr. Kuyateh is an educationist who has spent the better part of his working life in the noble profession of classroom teaching. In 1990, he joined the Sierra Leone Teachers' Union Executive as Assistant Secretary-General. He rose through the ranks to his current position as Secretary-General of the S.L.T.U.

Responding to question from the Committee on his opinion on privatization in his country, Mr. Kuyeteh said" Well, there are other activities which government has organized which are out. This House, which tells us the benefit of privatization and the ideas well gain from the board I will be able to learn more".

<u>Commodore Moses Bayemen Miller</u> – Proposed Member, Mineral Advisory Board

Commodore Miller joined the Sierra Leone Armed Forces in 1986 as Officer Cadet, soon after graduating from Fourah Bay College, University of Sierra Leone. He went to Ghana in 1994 for Maritime Studies which qualified him as a Pilot in the Navy Wing. He rose through the ranks to his current position as Chief of Defence Staff Support and Logistics.

Answering to questions from the Committee on his input on the board, Commodore Miler said "As a pure scientist, I know a bit about minerals, I think the aspect of leadership and disciplined will be at the forefront of my contribution to that board.

Questioned on the role the Mineral Board to monitor mining operations, Commodore Moses Miller said "The implementation agency there to the Mineral's Agencies which I will be advising from time to time a lot of loss and damaging has been done to mining in terms of the environment. So, we shall be advising them to give back in return for damages that might have been caused, also we shall be advising that government derives maximum benefit for those natural resources and as well as advise them on work ethics, discipline and getting things done adequately and on the right time and in good time.

Alhaji Mohamed Dondondo Bangura-Proposed Chairman, Sierra Leone State Lottery

Mr. Bangura is a retired Public Officer who has served in several institution in this country including the police, S.L.P.M.B. S.L. Ports etc. and has had extensive work experience abroad particularly in the former Soviet Union and China

Answering to questions from the Committee on the status of the State Lottery. Mohamed Dondondo Bangura said "when I get there will follow up"

Questioned on the competition State Lottery is getting in the lottery sector, Mr. Dondondo Bangura said "my sole aim is to make a difference when I get there to improve the standard.

Mrs. Kadie Sawyerr - Proposed Board Member Sierra Leone State Lottery

Mrs. Kadie Sawyerr is a Member of the ruling Party's Women Congress Organizing Group. She had founded, nurtured two important Associations as Executive Director that are still serving he Sierra Leone Community and these were:
