The House met at 10:07 a.m. in Parliament Building, Tower Hill, Freetown.

The House was called to Order

HON. CLAUDE D. M. KAMANDA: Mr Speaker, I move that S.O 5(2) be suspended so that the business of the House may commence.

(i) HONOURABLE KOMBA E. KOEDOYOMA, DEPUTY CHAIRMAN PUBLIC ACCOUNTS COMMITTEE (PAC)

HON. KOMBA E. KOEDOYOMA: Mr Speaker, Honourable Members, permit me to lay on the Table of this Honourable House the Audit Report of the Audit Service Sierra Leone, entitled: "Performance Audit Report on the Rehabilitation of Prisoners by the Sierra Leone Prisons Service, July 2013 (*Applause*).

(ii) THE CHAIRMAN TRANSPARENCY AND ACCOUNTABILITY COMMITTEE

HON. CLAUDE D. M. KAMANDA: Mr Speaker, Honourable Members, the Local Government Act of 2004 gives Local Councils more powers to decide on how to spend public funds in their areas so that they can meet local people's needs. Residence of the locality should be consulted before council approves it. Therefore, the Transparency and Accountability Committee, today presents to this House in accordance with Section 73(3) of the Standing Orders of our Parliament the report that covers all 19 councils in the country. The report is structures in two parts:

1. the executive summary; and

2. Committee sittings and evidences submitted by councils under oath.

Therefore Mr Speaker, Honourable Members, I beg to lay on the table the Report on follow-up and Sensitization Oversight to Local Councils Nationwide 2013 (Applause).

I am sure there is a notice and all Members are aware of this. I also like to announce that there is going to be a sitting tomorrow. The sitting for tomorrow should have been adjourned to next week, but because of certain circumstances, we are going to have a sitting tomorrow in lieu of the sitting that we would have had the following week.
