**HON. S. B. B. DUMBUYA:** Mr Speaker, Honourable Members, I present to you Second Excerpt of the 14<sup>th</sup> Report of the Committee on Appointments and the public Service on Parliamentary Vetting of Presidential Nominations.

### 1. Introduction

Mr Speaker, Honourable Members, the Committee on Appointments and the Public Service met on Tuesday, 11<sup>th</sup> June, 2013 and interviewed seven (7) Presidential nominees for appointments to the following positions:

### 2. Procedure

The Committee consistently followed its established procedures and put inquiring questions to the nominee pertaining to his educational backgrounds, track records in

relevant work situations, declared assets, tax obligations and his plans and visions for a successful tenure.

## 3. <u>NINETEENTH SITTING OF THE COMMITTEE ON TUESDAY, $11^{TH}$ JUNE</u> 2013

The following nominee was interviewed along six others:

<u>Mr Unisa Sahid Kamara, Proposed Board Member, Sierra Leone Civil</u> <u>Aviation Authority Representing the Ministry of Foreign Affairs &</u> <u>International Cooperation</u>

Mr Kamara joined the Civil Service in 1993 and after a brief sojourn in the Ministries of Health and Information, was posted to the Ministry of Foreign Affairs in 2000 as Assistant Secretary and has worked in that Ministry to date. He is currently the Director of Administration and Finance.

Responding to probing questions, Mr. Kamara noted that as an institutional representative on the board, he was capable of adequately representing the Ministry of Foreign Affairs and would do his best to meet the Ministry's trust and that of the Committee.

#### 5. Recommendation:

Mr Speaker, Honourable Members, the Committee adjudged the following Presidential nominee to be suitably qualified for his proposed appointment and is recommended to the House for approval: Mr Unisa Sahid Kamara, Proposed Board Member, Sierra Leone Civil Aviation Authority, Representing the Ministry of Foreign Affairs and International Cooperations.
