THAT THE SIXTH REPORT OF THE FIRST SESSION OF THE COMMITTEE ON APPOINTMENTS AND THE PUBLIC SERVICE BE ADOPTED BY THE HOUSE AND THAT THE RECOMMENDATIONS CONTAINED THEREIN BE APPROVED.

HON. SIDIE M TUNIS: Mr Speaker, Honourable Members, I present to you the Sixth Report of the First Session of the Committee on Appointments and the Public Service:

1. Introduction

Mr Speaker, Honourable Members, the Committee on Appointments and the Public Service, pursuant to its constitutional responsibility of vetting and approving of appropriately qualified candidates for appointment to public offices, met on Monday, 11th June, 2018 and interviewed one Presidential nominee for appointment as Chairman, National Assets and Government's Property Commission

2. Procedure

The Committee maintained strict consistency to its established procedure. Pertinent questions put to the nominee were related to his educational background, track record in public office, declared assets, tax obligation and his visions for a successful and nationally productive tenure. Issues of unsuitability or otherwise were closely looked into by the Committee.

3. Seventh Sitting Of The Committee On Monday 11th June 2018

Mr Speaker, Honourable Members, the following nominee was interviewed on oath:

Mr Abu Hindolo Moseray, Proposed Chairman, National Assets and Government's Property Commission

Mr Abu Hindolo Moseray is a businessman/politician since 2007 to date. He has served in various capacities, including that of Chief Executive Officer in a private business, [2000-2005], Manager in a Construction Company [1996-1999] and Site Manager in the Grafting Mining Company, Kono [1995-1996].

Reacting to the Committee's inquiries, Mr Hindolo Moseray promised to improve on the existing operations of the Commission and put in place the necessary mechanisms to identify, protect and maintain all such Government properties, including the legal instruments needed for their disposals.

Mr Abu Hindolo Moseray further promised to work collaboratively with all line ministries, particularly the Minister of Lands who had promised to reclaim all Government lands. He added that he would work with the Minister of Transport and Aviation who is in

charge of all Government vehicles to ensure that modalities are put in place to forestall theft of government vehicles.

4. Recommendations

Mr Speaker, Honourable Members, the Committee adjudged the following Presidential nominee to be adequately qualified for his proposed appointment and is accordingly recommended to the House for approval:

Mr Abu Hindolo Moseray, proposed Chairman, National Assets and Government's Property Commission.

Mr Speaker, Honourable Members, the Sixth Report is the unanimous decision of the Committee. I therefore move that the Sixth Report of the First Session of the Committee on Appointments and the Public Service be adopted by the House and that the recommendations contained therein be approved. Signed by Honourable Sidie Mohamed Tunis, Chairman.

THE SPEAKER: Any seconder to that Motion?

HON. BASHIRU SILIKIE: Mr Speaker, I so second the Motion.

[Question Proposed]

HON. BASHIRU SILIKIE: Thank you very much, Mr Speaker. Mr Speaker, Honourable Members, I want to begin by thanking His Excellency the President, for presenting to us somebody who should occupy a very important office. Today, we have in our midst a candidate who is going to serve as chairman for the protection of government's assets and property. I have no doubt in my mind that this candidate will perform this responsibility for which he has been appointed.

Mr Speaker, Honourable Members, I want to remind the candidate that the 'New Direction' is ready to develop this Nation. This suggests that there is no room for mistakes. You should be prepared to move that Commission forward because we have a contractual agreement between ourselves and the people of this country. As a government, we will develop and improve their lives. I want to advise that when you

take over that office, it is neither an SLPP office nor an APC office. It is an office for every Sierra Leonean [Applause].

Mr Speaker, Honourable Members, this was what we expected our brothers when they were on this side to have been advising those who were occupying state offices. We had always expected them to advise their ministers and other appointees. That would have helped develop this country. Thank you very much, Honourable Member. That is why we are here and that is exactly what we would do to keep you in opposition [Undertone].

Mr Speaker, Honourable Members, I want to remind this Nation that we are in a hurry, as a government and as a country, to develop this Nation. We got our independence in 1961, but there is nothing to write home about. The 'New Direction' is in a hurry because we want to develop the lives of the people of this country. We want to change their lives and that will happen under the leadership of his Excellency the President, Rtd Brigadier Julius Maada Bio and his lieutenants, like the nominee we have today. I want to admonish the nominee to go to that Commission and make sure that government properties are protected. He has to ensure that government assets are not misused and those who have personalised state assets are brought back to the government. Make sure you put in place a comprehensive National Assets Register. This has been lacking, but I am very confident that you will address this issue. Usually, government gives assets to people to make them confortable, but before they leave office, they personalise those assets. Please, make sure you retrieve those assets and provide adequate records of those assets. We want a situation wherein if somebody asks the whereabouts of particular asset, we should be able to find it on Google or otherwise.

Without much ado, Mr Speaker, Honourable Members, I recommend to this House that we approve this nominee, so that he will go and put in place all government assets. Thank you very much.

HON. DR KANDEH K. YUMKELLA: Mr Speaker, Honourable Members, before I make my own contribution to this debate, I would like to make an observation and a plea. I was not aware of the meeting yesterday. I am Member of the Committee on

Appointments. If you look at the Votes and Proceedings, you will find out that I pleaded last week for every document to be made available to us earlier enough, so that we can do due diligence. Again, I was not aware of this meeting and I checked this morning that in fact some people were called. If you look at it, you also find out that ten of us were not there. However, we are now in this situation and I want to plead that this does not happen again because it's twice in a row.

Having said that, Mr Speaker, Honourable Members, I would like to admonish our colleague that he has an important assignment to accomplish. I have only one issue I would like him to check for us. A year and half ago, we were informed that some of the government's quarters would be sold. Some of us went on radio to object because we did not think the process was transparent. We believed those are assets that belong to this Nation. In your new responsibility, therefore, we hope you will check whether the OAU Villas have been sold. We also want to know whether government's quarters have also been sold. We know that many government officials do not have housing facility, but if we do not want to use those facilities, we can build high rise buildings for government workers. I want you to crosscheck whether any government's property, especially the quarters have been sold. I campaigned against it and I am just hoping that we would rely on your good office to check. I am saying this because those assets belong to our people. Good luck in your responsibility. Thank you [Applause].

HON. SHIAKA M. SAMA: Thank you, Mr Speaker. I will use this opportunity to talk about a very important issue that I have observed over the years. Mr Speaker, before some of us were born, families leased lands to government. I grew up in Bo and I know some families in that part of the country that leased some property, especially land to government for about 50 years. I am sure the time has elapsed and if you go to Bo, you will find out that there are lots of problems with those leases. Some families are so weak that they have not been able to retrieve those lands from government. Again, past governments have not been able to right those wrongs. I want to appeal to the nominee that in his new responsibility, since we are now moving in the 'New Direction,' I would like him, with support from the President, to look at some of those property

that have ceased to be government, but government is still using them. Some of those families are so weak that they cannot hire lawyers to retrieve their properties. I would like you to consider this as part of your mandate. Some of those properties are no longer government's properties. We want government to seat with those families and revisit these agreements. Thank you, Mr Speaker.

THE SPEAKER: Honourable Member, we take note of your concern. You are still extending your previous role into this House. We take note of that and well done.

HON. JOSEPH WILLIAMS-LAMIN: Mr Speaker, Honourable Members, I want to remind Mr Abu Hindolo Moseray that 'we must succeed in the 'New Direction' and he should take it as his mandate. We have heard about many assets being owned by government, but within a twinkle of an eye, those assets disappeared. Therefore, you are about to take a very huge and herculean responsibility on behalf of this Nation. It takes a very hard tax payers money to acquire property; i.e. houses, vehicles, etc. When we took over governance, it was a big task to retrieve all government assets. People were running away with vehicles and others kept them in their kitchens like toys. Some of them thought they could not even afford to buy vehicles for themselves. You are about to take up that task. You have to be very strong in performing this task.

On that note, Mr Speaker, Honourable Members, I crave your indulgence to make sure that you do everything in you power so that you can succeed or we can succeed. Thank you, Mr Speaker [Applause].

THE SPEAKER: Thank you, Honourable Member. You may sit down at this point. I would like to draw the attention of the House to two very salient points made by the Honourable Kandeh Yumkella which I am compelled to bring to the attention of the Clerk so that we do not have a repetition of the same episode again. First, he drew our attention to the fact that he is a member of the Appointments Committee, but unfortunately he was not notified about the meeting, whereas other Members of that Committee were duly notified. I hope this will not happen again. Secondly and equally important is that Members should be given documentation well in advance of the discussion of those documents in the Well of this House, so that they will take the

opportunity to make due diligence before coming to the Well. That is a very important matter that again ought to be duly taken into account by the administration of the House. I hope, frankly, that we would not have occasion to draw attention to such important matters in the course of this session.

Honourable Member, your points are well noted and brought to the attention of Mr Clerk. I would not want to disrupt proceedings in future by drawing attention to these two important aspects of our work again. That being said, we may now proceed with the debate. I hope we can make it as short as possible because there are other things on the Order Paper we wish to address today.

HON HASSAN A. SESAY: Thank you very much, Mr Speaker. Mr Speaker, Honourable Members, I would not want to repeat what the Honourable Member from Kychum was saying about documents because he has flagged that point up. I hope it is a message well taken by the Leadership of the House.

Mr Speaker, Honourable Members, we are about to approve the Chairman of the National Assets Commission. Honourable Members have already spoken about the way and manner people have been handling government property. I know that handling government property is a herculean task. I am sure the proposed Chairman we are about to approve knows that he is going to face huge challenges.

Mr Speaker, Honourable Members, there is something that is very common among government property, particularly houses owned by government. We must accept the truth that civil servants who use these property sometimes do not take good care of these property; and in the end, they convert them as their personal properties. Some of them build houses on those lands, while they are still occupying government property. That has been a prevalent problem amongst civil servants. Mr Speaker, I must state here that we have to reconfigure the mind-set of civil servants if we are to progress as a Nation. We have to do that so that civil servants will know that government property are our property. They do not belong to one person. Therefore, people should not try to personalise something that belongs to the general public. Sometimes it will not workwell for even the individual, but people fail to learn from the lessons of history. It

is not about owning property, but people who occupy government property must be responsible. This is why, like my colleague said from the other side, to develop a comprehensive data for all government assets, so that from time to time, they will be properly monitored.

Mr Speaker, Honourable Members, if you go to Hill Station, for example, you will see some houses owned by government which are not properly taken care of. Some of the buildings are without occupants. People are not sleeping in those buildings and there is no proper care at all. If it were their personal property, I do not think whether they will abandon those properties. We have very little regard for government property in this country [Applause]. If this attitude does not change, our governments would not be boasting of anything good.

Mr Speaker, Honourable Members, sometimes we blame the government, but we are responsible for some of these problems. This is not about the government; it is about the the people because government is about people. It is the people that constitute government. These are the people who usually put the blame on the politicians, S.O [2] 'na da minista so.' That is not the case because **80%** of these properties are occupied by civil servants. We need to overhaul the mind-set of public servants. It is not only about the physical side of things, but also the mental side of it. People must change their attitudes in the way they handle government property.

Mr Speaker, Honourable Members, the same driver who manhandles a government vehicle, is the same driver who takes great care of a private vehicle. Mr Speaker, these are good appeals we are making, but the people who are occupying these offices must ensure that their personal relationships should not determine what you do with such people. If it is the law, it is the law; and if it is prohibited, it is prohibited. Let us do it across the board without fear or favour. Let us look at this issue from a national outlook and not from a personal outlook or from personal interest. We all have personal interests, but we should not compromise the interest of this Nation. These are the things the government will show to the public as government property. If we destroy

everything that is owned by government, how do you expect government to progress? We are making a sad mistake and it would be unfair to the government itself.

Mr Speaker, Honourable Members, the proposed Chairman has been approved by the Committee on Appointments and he is here to be approved by the entire House. I want to personally implore colleagues to approve him on the basis that we will also be monitoring his work. In other words, we will pay keen interest in his activities. He has to ensure that government property are retrieved and a data is maintained for future reference. Those who have built on government lands ought to know because they knew before they built on those lands.

Again, Mr Speaker, Honourable Members, the Ministry of Lands and the Environment has a role to play. It is not the Minister, but the middle level bureaucrats in the Ministry of Lands are the people who are causing the danger. We have had over seven Ministers in that Ministry, but the problems are still prevalent. It is not the Minister because the bureaucrats in that Ministry are just recycled. They misinform and misdirect the ministers for their personal gains. When the Minister is relieved of his/her duties, the civil servants stay; and when they stay, the same practice continues. Sometimes we attack the Minister wrongly. This should not be the case.

Mr Speaker, Honourable Members, parliamentarians only approve moneys, but we do not have the money. When you go to your constituency, people usually say S.O [2], 'na den dae eat govment money.' Where is the money coming from? We only approve moneys here, but we do not collect money. Our salaries are still not a thing to write home about, but we do our work. People do not even realise that coming to Parliament on daily basis costs money. We receive **Le400**, **000** as sitting allowance per month. We have to attend five parliamentary sittings and go to your constituency. Despite all these challenges, we are not complaining because we are politicians. We must not complain because we do not deserve the right to complain. We complain when necessary [Applause].

Mr Speaker, Honourable Members, the public servants are also using project vehicles for personal reasons, but they usually say, 'government does not have money.' They

will never move from those ministries. Government provides accommodation for them, vehicles, fuel, top-up, confectionaries etc.

Mr Speaker, Honourable Members, government assets belong to government and those are the things we own. What we lack in this country is maintenance culture. S.O [2] 'if na government you ar no go mek am' 'but if na yu yon yu go mek am'. That attitude ought to change if we want to upkeep government assets. We should understand that government property is what we own. It is your property and our property.

Mr Speaker, Honourable Members, I would like the nominee to make sure that things are done correctly. Let me not waste time to commend the President, Rtd Brigadier Julius Maada Bio for taking the prompt action [Applause]. It shows that where we need to commend the President, we would commend him. I am saying this because he has got rid of somebody who is very divisive, somebody who wants to bring friction rather than tranquillity to our political system. He is now the shortest serving Attorney-General and Minister of Justice in the history of Sierra Leone [Laughter]. If we should go by that, we will continue to give respect to the President for doing something in response to national interest, instead of personal interest. When people substitute national interest for personal interest, we will begin to have problems.

Mr Speaker, Honourable Members, I want to thank you for giving me this opportunity to say something on this issue. I will continue to say and point out the property that have been personalised by civil servants who are working for the government. I thank you very much, Mr Speaker [Applause].

THE SPEAKER: Honourable Members, I want to thank the previous speaker very much for articulating with great eloquence, a matter of public concern. Frankly speaking, you have also re-echoed that public concern. I am just wondering whether we should just be talking and talking in this House without taking appropriate action [Applause]. Therefore, I want to recommend, for your consideration, that when we come to compose the Standing Committees under Section 93 of the Constitution, you give due regard to the provisions of Sub-sections 2, 3 and 4 of that provision of the Constitution. Perhaps, you should consider consulting amongst yourselves, as you have always done,

in the composition of Standing Committees, to constitute a committee specifically on this matter. It is a matter of burning concern to the public. It would greatly assist the work of government and more particularly the work of the Assets Commission. So, it is some food for thought for you.

Honourable Members, if there is a Committee, it certainly not amongst the Committees that I am going to announce later on. But if there is a Committee of that nature, then we would mandate that particular Committee to pay special attention to the work of the Assets Commission. May be that is one way of getting around the difficulties. Their remit would include special attention on the work of the Asset Commission. Therefore, I want you to bear that in mind when we come to the part of constituting the various Committees before we adjourn the House.

HON. DR ROLAND F. KARGBO: Mr Speaker, I am going to make a very short statement. I want to thank His Excellency for this nominee. I also want to thank the Committee on Appointments for vetting and presenting him to us. The Chairman of this Commission is a very important person, so also other Chairmen of other Commissions. We expect him to steer the activities of the Commission professionally.

Mr Speaker, Honourable Members, I want to remind the nominee, we have not been able to go through the document to conduct a research on all documents that are related to this Commission, but I want to appeal to the nominee to do everything possible to put in place regulatory mechanisms through legislations that will serve as guidelines with regards the mandate, maintenance, acquisition and disposal of government properties. I want to see at the end of your tenure, mechanisms are being put in place to regulate government the use of property and assets. We are in this situation because we do not have guidelines to spell out what should be done with government assets. So, each person who comes in decides to do what he or she likes. I think this is not the right way and we must put an end to it. If we are going to make progress, we need to have some regulatory mechanisms that spell out what should be done with government property. I thank you, Mr Speaker.

THE SPEAKER: Thank you very much for your contribution. I now give the Floor to the mother of Parliament, Honourable Veronica K. Sesay.

HON. VERONICA K. SESAY: Thank you very much, Mr Speaker. Mr Speaker, Honourable Members, I want to thank His Excellency for this nominee. And let me tell you, S.O [2] 'talk am go talk am cam' our President is a very good coach. He has a very good team and each time you see His Excellency nominating somebody, that person is fit for the job. However, if you fall short, you would go and wait on the bench [Applause].

Mr Speaker, Honourable Members, having gone through the nominee's resume, I must say he is fit for the job. In fact, he is over qualified. However, that does not warrant him to go and relax. As you heard from my colleagues about the Government property, those property are being acquired from the taxes we pay to government. These are taxes the women pay to government. I am making reference to the women because we are vulnerable. Each time they talk about taxes, it is very difficult because we are talking about 30%, and 70% work done in every sphere, for women. To take that amount from our little income to pay tax and the Government acquires any property that belongs to the nation you should be very mindful that you are either destroying or making this country

Mr Speaker, Honourable Members, the nominee has a very big task ahead. Sometimes when these people acquire Government quarters, they say it is Government property. For God sake, you have to be descent. If there is a crack on the walls, please take cement or board and repair the crack. This is because when you go, somebody else will definitely come to take your place. Sometimes they leave those places in bad shape because People always say it is Government property or Government money.

Mr Speaker, Honourable Members, let me talk about government vehicles. Sometimes my heart bleeds when I see government vehicles carrying wood, charcoal and other things. My colleagues on the other side have gone, but we the 'PAOPAs' are here and we are here to stay for ten years. The SLPP will even come for another ten years [Applause]. This is just the 'PAOPAs' and the other ten years is SLPP. Therefore, we

need to work together and maintain the standard. The President has sent you there to represent him.

Mr Speaker, Honourable Members, if you go and inspect the OAU Villas, you see what my colleagues have been saying. People have taken the law into their hands. Some are residing there with no document. They will go there and build whatever they want to build. They thought they would stay there for the rest of their lives. Today, you are gone, but there are other people who are going to stay there. I want to admonish the nominee to go there and crosscheck. You are not going there as SLPP or 'PAOPA,' but you are going there to represent the people of this country. Remember, another person from the 'PAOPA' or SLPP will go there to stay. Please, go and crosscheck those who are occupying these premises without proper maintenance. If you meet a Minister or Government functionary, but he she fails to properly maintain his/her place, you have all right to ask him or her out because he/she needs to maintain and upkeep the standards of this country.

With those few words, Mr Speaker, Honourable Members, I humbly as my colleagues have said to hurriedly approve him because he needs to go and start work. The coach is waiting and the train is ready to go. I wish you good luck, if approved by this House. Make sure you work and let others follow. Thank you [Applause].

THE SPEAKER: Thank you for your contribution, Honourable Member. I will take two more speakers, one on the either side of the isle before we wind up the debate.

HON. SIRAJIN M. ROLLINGS-KAMARA: Thank you, Mr Speaker. Mr Speaker, Honourable Members, I want to draw the attention of the nominee to the correlation his department or agency has with the Ministry of Transport. According to the Committee's Report, the nominee said that he would work with the Minister of Transport, who is in charge of all Government vehicles, to ensure that modalities are put in place to forestall theft of Government vehicles. I want to draw your attention to something that is very important. We used to have the Ministry of Works and Road Transport that service Government vehicles, but that practice has changed over time. Today, government vehicles are taken to local garages. Maybe, this is where we lost a lot of vehicles. I

think we have to review the work of the Ministry of Works, so that government vehicles are serviced by this Ministry, thereby providing jobs for young men and women in the country. This could also help to keep records of government vehicles because you now have a pool where these vehicles are serviced instead of these splinted garages. I think that is very important and it would also help us to manage our resources well. Thank you.

HON. P.C. SAHR YOUNGAI KONTANDAY MBRIWA II: Mr Speaker, I hail from Fiama Chiefdom, Kono District. I would like to join the previous speakers to thank His Excellency the President of the Republic of Sierra Leone for giving us this fine gentleman. I would personally wish to advise him that we are looking forward to success in this country. We are praying that he would rise to the presidential and the parliamentary confident that is being placed on you. I do not know the scope of your work, but I am aware that land issue is a very sensitive issue, as well as Government assets. From what the other speakers have said, emphasis is being placed on assets, may be in Freetown and in the cities, but I am sure government has assets and properties across the country since the colonial period to date. May be, for some of the property in the provinces, we are not fully aware of their status simply because of bad governance. However, now that the Government has put a structure in place to investigate some of these issues, I am inclined to believe that you will be going to the provinces to meet the Chiefs. We are ready to give you the support and cooperation you will need. We need a clear policy on the scope of your work, so that when you go to our Chiefdoms, you will be given the full support and cooperation.

Mr Speaker, Honourable Members, we know the District Commissioners used to have quarters, but those quarters are no longer in existence. There were also protected forests and we do not know whether they are Government property or not, but they were protected by the government. Also, maybe I am going far and wide, but even the Chiefdoms, there are Government assets and property. You may be aware that we have many inter-Chiefdoms, inter-districts as well as inter-provincial district boundary disputes. All these are assets and property that belong to Government, but they are not

been properly taken care of. This is why we have boundary disputes and they are negatively impacting on the peace and stability of the local people in these areas. We would be interested in knowing exactly how you are going to work with the Chiefdoms because they also have Government assets. How can we collaborate with you to ensure that you succeed should be your concern. So, it is a whole complex issue and it is going to take a lot. We are however looking forward to working with you. I want to say at this point that we wish you good luck and we pray that you live up to the expectations of the President as well as Parliament. Thank you, Mr Speaker [Applause].

THE SPEAKER: I thank the Honourable Paramount Chief for his contribution. We now wind up the debate and I call on the Leader of the Opposition.

HON. CHERNOR R.M. BAH [Leader of the Opposition]: Mr Speaker, I keep reminding you on a daily basis that you cannot run away from the majority because it is extant. However, thank you very much. All those who have spoken before me have done their best, but fortunately I was part of the interview yesterday and the shortest advice I proffered had to do with working of the Assets Commission is relationship with; i.e., the now Ministry of Housing. Housing has been separated from Works. I wonder why the proposed Chairman of the Works Committee is chasing the Asset Commission. I want to tell him that Housing has been moved from Works and has been appendage to the Ministry of Lands. The nomenclature of the Minister we approved in this Well, is Minister of Lands, Housing and the Environment. So, the Committee on Works should think about this.

Mr Speaker, Honourable Members, the other major asset of Government has to do with Government vehicles as other speakers have said. This again is under the purview of the Ministry of Transport and not the Ministry of Works. These form the bulk of Government assets; i.e., land, vehicles and real property. These are the three assets that are outside the remit of the Ministry of Works. As a Parliament, we would cooperate and support the Chairman, if approved by this House. I will make that recommendation because I did so in the Committee. I will also do it this morning to recommend for his approval. We should support him in whatever form. He is a very

young man. I think I knew him when we were in school. He was slightly my senior, [Laughter]. We should support him because it is difficult to succeed alone.

Mr Speaker, Honourable Members, the ideas to support the nominee should come from all the corners of this House. We have neighbours who stay in Government property and they are also using Government vehicles. The information must filter down and it is our responsibility as patriotic citizens, so that we can support the right course. I have just learnt this morning that there is a party called 'PAOPA'. I thought that the 'PAOPA' is an extension of the SLPP. I learnt that from the mother of the House. Today, we have a party called 'PAOPA.' I will be looking at the PPRC register to confirm whether that party is registered [Laughter]. Maybe it is registered somewhere in Moyamba and not in Karene.

THE SPEAKER: Honourable Member, I know of two; one is called 'PAOPA' and the other is called 'TOLONGBO' [Applause].

HON. CHERNOR R.M. BAH: Mr Speaker, I agreed with you, but the distinction here is that 'TOLONGBO' is APC. For 'PAOPA,' we have just been told that it is not SLPP. That is the distinction and that distinction is serious. In any case, I want to recommend two things: we collectively support the Chairman after he has been approved by the House and I want to encourage all of us to approve his nomination. I thank you very much [Applause]

THE SPEAKER: I thank you for your contribution, Honourable Member. I call on the Honourable Leader of Government Business.

HON. SIDI M. TUNIS: Mr Speaker, Honourable Members, I want to thank my colleagues for supporting our nominee. He is a gentleman and he is very good. He has a very good track record and he is a successful business man. I only want to remind him that the job of the Chairman of this Commission is so important and the task is daunting. I want to assure him of our support in this Parliament and I will, at this point, call on the Ministry of Finance, especially the Minister and the Financial Secretary, to ensure that they give him all the support. We should not just have a Commission. If we

have a Commission without the necessary finances to work, it is not going anywhere and indeed it is very important at this stage to have a Commission that would actually look at Government assets. Assets of Government are scattered all over the country and nobody seems to be in control. I am therefore hoping that the Ministry of Finance will provide every support to this Commission to ensure that they carry out their duties. Thank you very much [Applause].

[Question Proposed, Put and Agreed to]

[Motion of the Committee on Appointments and the Public Service has been carried]

We welcome them to Sierra Leone and we wish them well. Thank you for coming.

Honourable Members, on behalf of the House, I wish to congratulate and extend our warmest felicitations to Mr Abu Hindolo Moseray, who has just been approved by the House for the position of Chairman, National Assets and Government Property Commission. Mr Abu Hindolo Moseray has heard from the speakers who have taken the Floor, the great tribute paid to his ability and his competence. And indeed, I think the entire House would like to acknowledge that he is fully qualified to occupy the position for which His Excellency has nominated him. We wish you well. We believe and hope that indeed you will discharge your responsibilities with a high sense of commitment

and purpose that you will not let neither His Excellency down, nor this Honourable House or the general public. The confidence and trust reposed in you will be with you throughout your tenure. We hope it would last for the next five years and we are very pleased that you have been nominated and approved for that position. We hold you in high confidence and we do hope you will discharge your responsibilities with distinction. Thank you and you are now released to go and execute your tasks [Applause].

IV. LAYING OF PAPER

HON. SOLOMON SEGEPO THOMAS, CHAIRMAN, PUBLIC ACCOUNTS COMMITTEE

HON. SEGEPO THOMAS [Deputy Speaker of Parliament]: Mr Speaker, Honourable Members, here is the Auditor-General's Report on Accounts of Sierra Leone 2016. Mr Speaker, it is strange that this Report was not laid in this House during the last Parliament. In fact, during the last Parliament, I noticed that this Report was brought to Parliament for distribution to Members of Parliament. Unfortunately, this document was speedily withdrawn. I do not want to enquire as to why this document was withdrawn, but as a Committee, we will take the recommendations in this Report very seriously. This has always been the case in the Republic of Sierra Leone. We spend huge resources on institutions to investigate certain matters, but at the end of the day, when these reports are produced and recommendations are preferred, they lay waste.

Mr Speaker, Honourable Members, as a Committee and as a member of a responsible Government, we want things to be done differently this time. I intend, as Chairman of the Public Accounts Committee, to follow the recommendations of this report to the latter. In the circumstance therefore, I crave your kind indulgence to table the Report of the Auditor-General on the Accounts of Sierra Leone, 2016.

THE SPEAKER: Honourable Member, leave is so granted, but let me foreshadow here and now that unlike previous years when the reports were allowed to gather dust, this time around, the fullest debate will be encouraged on the report of the Auditor-General 2016 [Applause].

HON. BASHIRU SILIKIE: Mr Speaker, Honourable Members, I stand on S.O. 25, in tandem with Section 119 subsection 5 of the Constitution.

THE SPEAKER: SO what?

HON. BASHIRU SILIKIE: Mr Speaker, I stand on S.O. 25 to give a 'Notice of Motion,' in tandem with Section 119, Sub-section 5 of the 1991 Constitution of Sierra Leone.

Considering the importance of this document, I move that we debate this document as presented by the Deputy Speaker of the House. Thank you.

HON. CHERNOR R.M. BAH: Do I have your permission, Mr Speaker?

THE SPEAKER: Before I ask for a seconder?

HON. CHERNOR R.M. BAH: Yes, Mr Speaker.

THE SPEAKER: Okay, you have the Floor.

HON. CHERNOR R.M. BAH Mr Speaker, Honourable Members, during the course of the Presidential debate, I vividly remember making a submission; vis-à-vis, the relationship between the PAC and that of the Office of the Auditor-General. The Public Accounts Committee is a special Committee of this House. That is why if you look at the Standing Orders, the membership is lesser than all Select Committees. I did say on that very day that the Office of the Auditor-General is an office under Parliament. The concept of the Public Accounts Committee is something that we borrowed from the Westminster style of governance. The report that has just been laid contained queries and opinions proffered by the Auditor-General. This is clearly stated in the report itself. It is now the duty of the Public Accounts Committee to take ownership of the report and work in collaboration with Office of the Auditor-General who will provide the expertise needed in ensuring that we do a perfect job. Mr Speaker, I hope you are with me?

THE SPEAKER: I am listening, Honourable Member.

HON. CHERNOR R.M. BAH: Thank you very much sir. Debating the report before hearings are held by the PAC is like putting the 'cart before the horse' and that is the procedure all over the world. Fortunately, the Auditor-General is here with some of her most senior staff. In recent years, we have made tremendous progress as far as the office of the Auditor-General and the PAC are concerned in the Republic of Sierra Leone. I said it and I am going to repeat it again that before we entertain that particular Motion, we have to go back and confirm what the procedure is, so that we

will not make a mistake. This is very serious and I am kindly asking your indulgence to ensure that this Motion is deferred.

THE SPEAKER: It is only a Notice of Motion, Honourable Member.

HON. CHERNOR R.M. BAH: The perception, Mr Speaker.

THE SPEAKER: It is only a Notice of Motion that the Honourable Member has tabled and it is not yet the Substantive Motion. Honourable Leader of the Opposition, I am sure you will agree with me that it is in the public interest that this report be debated at an appropriate time.

HON. CHERNOR R.M. BAH: We should ensure that we follow procedure, but we have to do what is right and nobody will disagree with you on that.

THE SPEAKER: Thank you, Honourable Member.

HON. CHERNOR R.M. BAH: If we fail to follow procedures, we will also face the wrath of the very public we are trying to please.

THE SPEAKER: Thank you very much. On that note, we shall duly follow the procedures scrupulously.

HON. CHERNOR R.M. BAH: Thank you very much sir.

THE SPEAKER: So far, what is before the House is a Notice of Motion and not a Substantive Motion. It will come in due course. Honourable Leader of the Opposition, I think I resolute here the intention of every Member of this House that unlike previous years, it is the intention of this House that we debate the report of the Auditor-General that has just been laid before the House [Applause]. In fact, not only this report, but all previous reports that have been allowed to gather dust over the years [Applause]. I am sure you will agree with me on that.

HON. CHERNOR R.M. BAH: Mr Speaker, as I said earlier and I will repeat that again there is nothing Members of Parliament can go against that falls within the rules of this House. I also want to assure you that the last report before this, hearings were held, the report of the Public Accounts Committee which is what is supposed to be debated,

was tabled in this House and debated. I agree with you because as the public is waiting. They are watching and we have to follow procedures. That is all I wanted to say.

THE SPEAKER: Let me assure you, without a doubt in my mind, that all procedures will be faithfully followed.

HON. CHERNOR R.M. BAH: Thank you very much, Mr Speaker.
