AGREEMENT BETWEEN THE GOVERNMENT OF THE ISLAMIC REPUBLIC OF MAURITANIA AND THE GOVERNMENT OF THE REPUBLIC OF SIERRA LEONE FOR THE PROVISION OF A GRANT TO ASSIST IN THE FIGHT AGAINST EBOLA

This agreement is made this Tuesday 6th of January 2015, between The Government of the Islamic Republic of Mauritania (hereinafter called "The Grantor") and the Government of Sierra Leone (hereinafter called "The Grantee").

WHEREAS:

- The Republic of Sierra Leone, one of the most affected countries by Ebola, is exerting tremendous efforts to overcome the various challenges related to this serious crisis.
- As part of the African solidarity, the Government of The Islamic Republic of Mauritania is committed to providing an emergency response to the Ebola crisis by helping the affected countries to stop the spread of infections, improve public health systems, and assist these countries in coping with the economic impact.

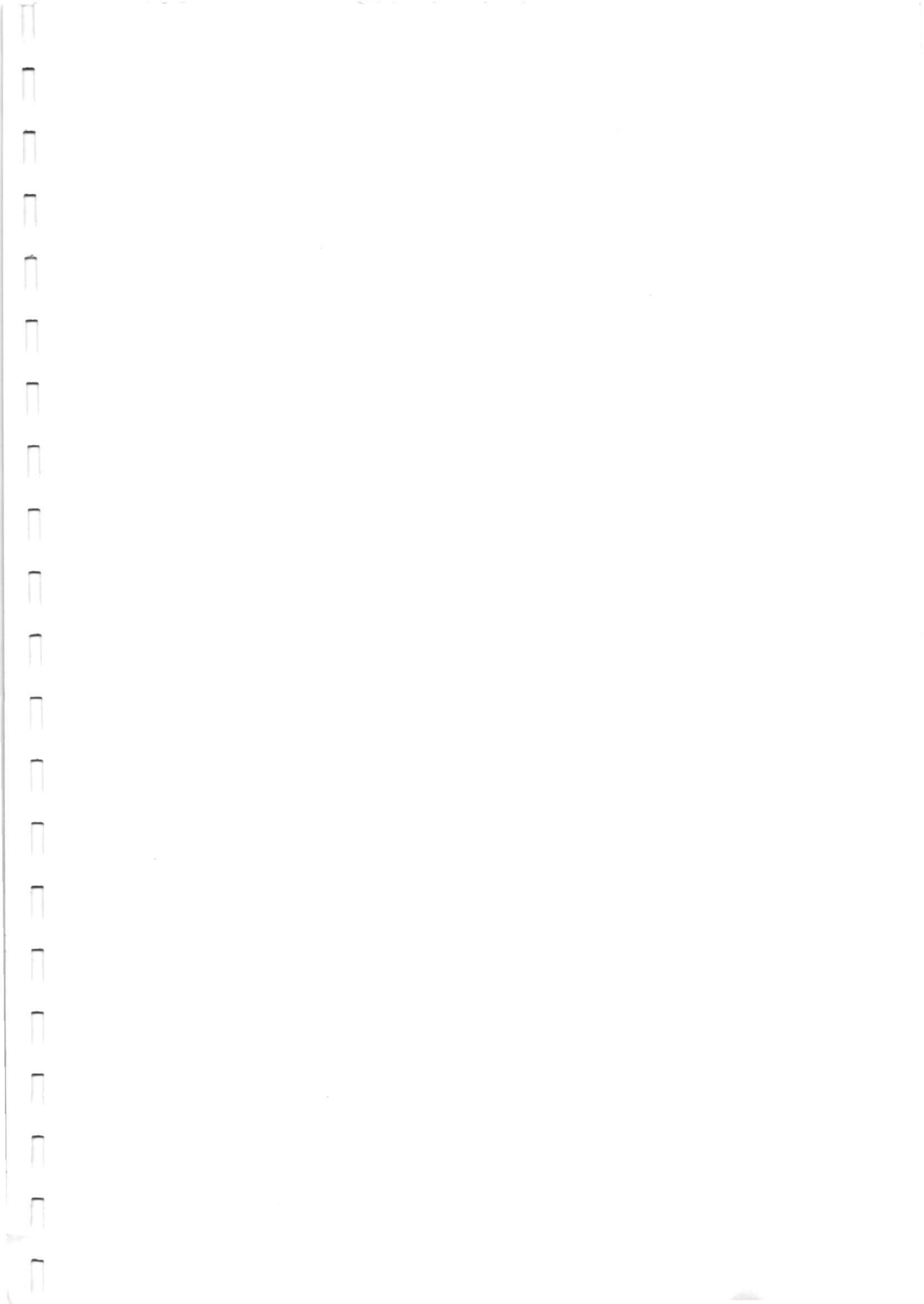
NOW THEREFORE, the parties hereto agree as follows:

Article 1: Purpose

The purpose of this agreement is to clarify the terms and conditions of the provision by the Grantor to the Grantee of a financial assistance to help in the fight against Ebola.

Article 2: Amount

The Grantor agrees to provide the Grantee an amount of Le 1690 Millions SSL



Article 3: Payment Terms

The grant will be transferred in a single payment via wire transfer to a bank account which will be specified by the Grantee.


Article 4: Entry Into Force

This Agreement shall enter into force on the date of signature by both parties.

Done at Freetown (Sierra Leone), this sixth day of January, 2015, in two copies in Arabic and English languages, each considered as original and all to the same and one effect.


