CERTIFICATION (ELECTRICAL CONTRACTORS,
MANUFACTURERS AND IMPORTERS OF ELECTRICAL
MATERIALS AND EQUIPMENTS) RULES, 2019

Short title.

In exercise of the powers conferred upon it by section 66 of the Sierra Leone Electricity and Water Regulatory Commission Act 2011, the Commission makes the following rules-

PART I-PRELIMINARY

Interpretation.

1. In these rules, unless the context otherwise requires -

“Act” means the Sierra Leone Electricity and Water Regulatory Commission Act, 2011 ;

“approved standard” means a standard adopted or recommended by the Standards Bureau for application in Sierra Leone ;

“artisan” means an electrician who is qualified through an apprenticeship programme and has been certified;

“associate engineer” means a person with the technical school certificate Level 4 of NCTVA certified for level 4 in construction or the equivalent in a relevant field;

“consultant” means an engineer or engineering company which has been issued with a certificate to provide services relating to the design, engineering, procurement and construction or project supervision;

“contractor” means an individual or a company that has been certified to undertake electrical or electromechanical contracting, including installation and maintenance;

“contracting company” means an electrical or electromechanical entity which is registered with the related trades certificate;

“Council” means the Sierra Leone Professional Engineers Registration Council established under section 2 of the Professional Engineers Act 1990;

“electrical activity” includes electrical design, installation, maintenance, testing, inspection, contracting, consultancy, inspection and the manufacture and importation in various electric electrical goods and materials;

“electrical professional” means an engineer of all classes or a technician of all grades or both that has an electrical or relevant technical educational qualification of a degree, diploma or certificate in electrical or technical training;

“engineer” means a person with a Bachelor of Science or engineering degree or higher or an equivalent qualification in an approved course in electrical or mechanical engineering from a recognized university or equivalent institution and is a member of the Professional Engineers of Sierra Leone and is duly recognized as such by the Council;

“experience” means verifiable previous personal involvement in or practice of electrical or electromechanical and other related activities;

“import” means the importation of electrical goods and materials;

“importer” means a person certified to import electrical goods and materials;

“inspector” means a person certified to undertake the inspection and testing of new, existing or rehabilitated facilities;

“junior technician” means a person who has completed the Level 1 of NCTVA and successfully undergone at least six months of technical training from a recognised training centre or a supervised mentorship or apprenticeship programme;

“manufacturer” means a person certified to produce electrical goods and materials;

“NCTVA” means the National Council for Technical, Vocational and Other Academic Awards established under the National Council for Technical, Vocational and Other Academic Awards Act 2001;

“material and equipment” include electrical plant, equipment, cable, wires and appliances;

“senior technician” means a person with the technical school certificate Level 3 of NCTVA certified for level 3 in construction or the equivalent in a relevant field;

“technician” means a person with the technical school certificate Level 2 of NCTVA certified for construction or the equivalent in a relevant field.

2. These Rules shall apply to electrical professionals or electrical Application. companies that undertake-

(a) electrical activities which includes-

- (i) electrical design;
- (ii) installation;
- (iii) maintenance;
- (iv) testing;
- (v) inspection;
- (vi) contracting;
- (vii) consultancy;

(b) electromechanical activities;

(c) manufacture of electrical goods and materials;

(d) importation of electrical goods and materials.

PART II- APPLICATION FOR CERTIFICATE AND OTHER
RELATED PROVISIONS

Require-
ment for a
certificate. 3. A person shall not undertake any activity under these rules
unless that person holds a certificate issued by the Commission for that
specific purpose.

Application

icate. 4. (1) A person wishing to undertake any activity under these
rules shall submit a written application to the Commission in the
prescribed form.

(2) A person applying for an-

- (a) electrical professional certificate shall fill out the form set out in Schedule 1-A;
- (b) electrical contractor's certificate shall fill out the form set out in Schedule 1-B;
- (c) electrical consultant or inspector's certificate shall fill out the form set out in Schedule 1-C;
- (d) electrical manufacturer's certificate shall fill out the form set out in Schedule 1-D;
- (e) importers certificate shall fill out the form set out in Schedule 1-E.

(3) The applicant shall –

- (a) attach all relevant documentation to the application form;
- (b) sign the application and address it to the Commission;
- (c) pay the prescribed fee as determined by the Commission and published in the Gazette; and
- (d) deliver the application by post or email .

Issuance of
certificate 5. (1) The Commission shall-

- (a) acknowledge receipt of the application made under rule 4 within 10 days of receiving the application;

(b) inform the applicant in writing of its decision within 30 days of receiving the application.

(2) The Commission shall issue a certificate to the successful applicant subject to the applicant meeting the requirement set out in the Act or statutory instruments made under the Act.

(3) Where the Commission refuses the application it shall communicate its decision to the applicant within 30 days stating the reasons for the refusal.

6. Subject to these rules the Commission shall issue any of the following certificate – Types of Certificate.

- (a) electrical professional's certificate;
- (b) electrical contractor's certificate;
- (c) consultant or inspector's certificate;
- (d) manufacturer's certificate; and
- (e) importer's certificate.

7. The applicant whose application is successful shall pay the certificate fee as determined by the Commission and published in the Gazette. Certificate Fee.

8. (1) A certificate issued under these rules shall be valid for a period of 3 years in the case of an individual and 5 years in the case of a corporate body. Duration of Certificate.

(2) A certificate may be renewed at the end of its term subject to the holder complying to the terms and conditions of the certificate.

9. A holder of a certificate shall pay an annual fee as determined by the Commission and published in the Gazette. Annual fee.

10. (1) The Commission may suspend or cancel a certificate where it is satisfied that - Suspension or cancellation of certificate.

- (a) the holder has contravened a term or condition of the certificate;

- (b) the holder has given information to the Commission which is false or misleading;
- (c) it is in the public's interest to do so.

(2) When the Commission has grounds for the suspension or cancellation of a certificate it shall notify the holder of its intention and shall give the holder an opportunity to show cause why the certificate should not be suspended or cancelled.

(3) Where the holder of the certificate is unable to persuade the Commission or fails to respond to the notice, the Commission shall proceed to suspend or cancel the certificate in accordance with section 35 of the Act.

(4) The Commission shall restore the certificate when the holder remedies the defect that gave rise to the cancellation or suspension.

PART III-CATEGORIES OF CERTIFICATE

ELECTRICAL PROFESSIONAL'S CERTIFICATION

Electrical Professional's Certification.

11. (1) The Commission shall categorise the electrical professional's certification into the following categories-

- (a) engineer;
- (b) associate engineer;
- (c) senior technician;
- (d) technical;
- (e) junior technical
- (f) artisan

(2) The Commission shall classify the categories outlined under sub-rule (1) in accordance with the applicant's education and experience as follows-

- (a) Class A;

- (b) Class B;
- (c) Class C; and
- (d) Class D

(3) The qualification criteria for each class outlined under sub-rule (2) shall be as set out under Schedule 2A.

(4) The technical work limit for each class of electrical professionals shall be as set out under Schedule 2B.

ELECTRICAL CONTRACTOR'S CERTIFICATION

12. (1) The Commission shall categorise the electrical contractor's certification into the following categories- Electrical Contractor's Certification.

- (a) Class 1;
- (b) Class 2;
- (c) Class 3;
- (d) Class 4;
- (e) Class 5 .

(2) The qualification criteria for each class outlined under sub-rule (1) shall be as set out under Schedule 2C.

(3) The technical work limit for each class of electrical contractors shall be as set out under Schedule 2D.

(4) The criteria for evaluating contractors shall be as set out in Schedule 3.

(5) The personnel and equipment requirement for contractors shall be as set out in Schedule 4.

ELECTRICAL CONSULTANT CERTIFICATION

13. (1) The Commission shall categorise the electrical consultant's certification as follows- Electrical Consultant's Certification.

(a) Class A;

(b) Class B.

(2) The qualification and experience criteria for each class of electrical consultant shall be as set out under Schedule 2E and Schedule 5 respectively.

(3) The technical work limit for each class of electrical consultant shall be as set out under Schedule 2F.

ELECTRICAL INSPECTOR'S CERTIFICATION

14. (1) The Commission shall categorise the electrical inspector's certification as follows-

(a) Class A;

(b) Class B.

(2) The qualification and experience criteria for each class of electrical Inspectors shall be as set out under Schedule 2G and Schedule 5

(3) The technical work limit for each class of electrical inspectors shall be as set out under Schedule 2H.

(4) The Commission shall establish guidelines determining the framework for inspection of electrical installations and works.

ELECTRICAL MANUFACTURER CERTIFICATE

15. The holder of a manufacturing certificate shall ensure that –

(a) the material and equipment produced meet the Sierra Leone or approved international standard;

(b) it employs competent personnel of the requisite qualification for the type of material and equipment produced and nature of processes undertaken;

- (c) there are adequate facilities for the storage of material and equipment for undertaking the business;
- (d) sound environmental principles are observed during its operations; and
- (e) the manufacturing is undertaken with due regard to health and safety of the workmen and the public.

ELECTRICAL IMPORTER'S CERTIFICATE

16. (1) The holder of an electrical importer's certificate shall ensure that - Electrical Importer.

- (a) the goods and material imported meet the Sierra Leone or approved international standards; and
- (b) an adequate requirement of qualified personnel and facilities are employed in his business.

PART IV-EXAMINATION

17. (1) The Commission may examine an applicant through a written examination, performance test and if it deems it necessary a practical test before the certificate is upgraded or granted. Evaluation and Grading.

(2) The Commission shall develop or appoint a professional entity to develop a curriculum for the training and continuous education and examination of electrical professionals.

(3) The outline of the curriculum referred to in sub-rule(2) shall be based on the technical codes, standards and rules of practice of the electricity sector.

(4) The Commission may establish a Committee to be known as the Electrical Works Certification Committee which shall be responsible for conducting the written examination, performance and practical tests or.

(5) The Commission may outsource the responsibility of conducting the written examination, performance and practical tests to an appropriate external professional or educational body.

18. (1) The Commission shall notify the applicant in writing of the applicant's written examination, performance and practical test results.

(2) An applicant who is not successful in a written examination, performance and practical tests conducted by the Commission may re-take the written examination, performance or practical test after six months from the publication of the results.

19. An applicant who has served a minimum 10 years with a governmental agency, licenced public utility company or other relevant organization may apply to the Commission to waive the written examination, performance and practical test requirements.

20. The Commission may-

(a) issue guidelines on the procedures for written examination and performance and practical tests;

(b) set criteria for waiving the written examination performance and practical tests.

PART V-MISCELLANEOUS PROVISIONS

Reporting

21. (1) The holder of a certificate shall submit an annual report to the Commission on its activities for each operation

(2) The report referred to under sub-rule (1) shall be submitted before the end of the first quarter of the following year.

Register.

22. (1) The Commission shall maintain a register of certified persons and the type of services they are qualified to perform.

(2) The Commission shall publish the list of certified persons in the Gazette.

Offences.

23. A person who –

(a) is not a holder of a certificate issued by the Commission and undertakes any activity for which a certificate is required under these rules;

- (b) employs persons without a certificate to undertake any activity for which a certificate is required under these rules;
- (c) obstructs a member of the Commission or authorised officers of the Commission in the exercise of their duties under the Act or these rules,
- (d) fails to comply with other provisions of these rules.

commits an offence punishable under section 65 of the Act.

24. A person who prior to the commencement of these rules ^{Transitional} was engaged in an activity requiring a certificate under these rules shall ^{Provision.} within 3 months of the coming into effect of these rules apply for the relevant certificate.

Part 1: Criteria for Grading of New Contractors

1. Scope of works for each class based on generation capacity level, transmission or distribution levels which are ultra-high Voltage, high voltage, medium voltage and low voltage and load size in kVA capacity
2. Number of qualified professional employed by the organization
3. Size and layout of office facilities
4. Transport and plant, machinery, equipment capacity as needed for undertaking jobs professionally
5. Value of projects handled
6. Availability of relevant applicable laws, regulations, codes, technical manuals, procedural manuals
7. Testing and measurement equipment
8. Insurance policy

Part 2: Criteria for Grading and Upgrading Contractors

1. Financial soundness from bank statement or Working Capital availability such as overdraft facility from bank and fixed deposits receipts with banks
2. Value of assets
3. Track record and evidence of works
4. Financial capability from tax clearance, equity, liability and credit statements and guarantee
5. Insurance guarantee

EXPLANATORY MEMORANDUM

(This explanatory memorandum is not part of these rules but is intended to indicate its general purport)

This statutory instrument is made pursuant to section 66 of the Sierra Leone Electricity and Water Regulatory Commission Act 2011. This instrument is divided into 5 parts .

Part 1 covers the interpretation and application provisions. The interpretation provision defines words and expressions used throughout the instrument .The application provision stipulates that the instrument applies to electrical professionals or electrical companies that undertake the following activities

- (a) Electrical activities which includes –
 - (i) Electrical design;
 - (ii) Installation;
 - (iii) Maintenance;
 - (iv) Testing
 - (v) Inspection
 - (vi) Contracting
 - (vii) Consultancy
- (b) Electromechanical activities;
- (c) Manufacture of electrical goods and materials ;
- (d) Importation of electrical goods and materials

Part II covers provisions relating to the application for a certificate. The instrument provides that no person should undertake any activity prescribed under the instrument unless the person holds a certificate issued by the Commission for that purpose.

Part III covers provisions on the categories and classes of certificates

Part IV covers provisions on evaluation and training

Part V contains miscellaneous provisions. The instrument criminalises among other things actions that are undertaken without certification.
