HIGH COURT (APPOINTMENT OF CRIMINAL SESSIONS) ORDER, 2019 Short title.

IN EXERCISE of the powers conferred upon me by Paragraph (2) of Rule 2 of the High Court (Criminal Sessions) Rules 1965, I as the Chief Justice of the Republic of Sierra Leone do hereby make the following Orders-

1. That the High Court shall hold Criminal Sessions in Kono on the last Monday in January, the third Monday in May, the third Tuesday in September and the last Monday in November in the year 2020.
2. That the following times and places are now appointed for the holding of Criminal Sessions of the High Court in places other than Freetown, Bo, Kenema, Makeni and Kono for the year 2020.
