### (b) Honorary Members

All legal practitioners entitled by law to practise law in Sierra Leone, who have submitted a successful application in writing to the Director of the Sierra Leone Law School for that purpose.

#### Benchers

Persons invited by the Council of Legal Education from among eminent and distinguished members of the legal profession who are entitled to practise law in Sierra Leone.

#### Honorary Benchers

Persons invited by the Council of Legal Education from among eminent and distinguished members of the legal profession not entitled to practise law in Sierra Leone.

Rights and priviledges of Benchers.

# 3. Benchers of the Sierra Leone Law School —

- (a) shall be entitled to attend all Call Ceremonies. dinners and other formal functions organized by the Sierra Leone Law School and Council of Legal Education;
- (b) shall be entitled to join the Chairman's procession during Call Ceremonies and on all other ceremonial occasions of the Sierra Leone Law School:
- shall be robed at all Call Ceremonies, dinners and other formal functions organized by the Sierra Leone Law School and Council of Legal Education.

# THE COUNCIL OF LEGAL EDUCATION ACT, 1989 (Act No. 1 of 1989)

THE COUNCIL OF LEGAL EDUCATION REGULATIONS, 2007

Short title.

In exercise of the power conferred upon it by Section 22 of the Council of Legal Education Act, 1989 the Council hereby makes the following Regulations-

1. (1) There is hereby established a body to be known as Establishment the Sierra Leone Bar to which all students of the Sierra Leone Law. of the Sierra Leone Bar. School shall be admitted and called on the satisfactory completion of their course of study and professional training at the Sierra Leone Law School.

- (2) For the purpose of admission and call to the Bar under sub-paragraph (1), there shall be held, at least once a year, a Call Ceremony to be organized by the Council of Legal Education.
- 2. Membership of the Sierra Leone Bar shall comprise the Membership of the Sierra following categories of persons -Leone Bar.

### (a) Ordinary Members

All students of the Sierra Leone Law School who prior to the coming into force of these Regulations have completed the course of study and professional training organized by the Council of Legal Education and all students of the Sierra Leone Law School who having completed the course of study and professional training organized by the Council of Legal Education shall be entitled to be admitted and called to the Bar after the coming into force of these Regulations.
