THE FISHERIES (FEES) REGULATIONS, 2017

Short title.

In exercise of the powers conferred on him by section 107 of the Fisheries Management and Development Act, 1994, the Minister hereby makes the following Regulations-

1. The fees and royalties set out in the First Schedule shall be Licence Fee charged for the issuance of the corresponding licences set out in the **First Schedule**.
2. The fees set out in the Second Schedule shall be charged Supplementary fee for the corresponding item and services set out in the **Second Schedule**.
3. The Fisheries (Fees) Regulations, 2008 are hereby revoked Revocation of S.I No. 6 of 2008.
