THE CONSTITUTION OF SIERRA LEONE, 1991 (Act No. 6 of 1991)

The Public Emergency (Detention) Order, 2014

Short Title.

WHEREAS the President is of the opinion that for the purpose of maintaining and securing peace, order and good government in Sierra Leone, it is necessary to make an Order directing that the persons named in the Schedule be detained:

Now THEREFORE, in exercise of the powers conferred upon him by subsection (6) of section 29 of the Constitution of Sierra Leone, 1991, the President hereby makes the following Order–
