THE POLITICAL PARTIES (ELECTION FINANCE REPORTING)  
REGULATIONS, 2007

Short title.

In exercise of the powers conferred upon it by Section 32 of the Political Parties Act, 2002 the Commission hereby makes the following Regulations—

1. The National Secretary or General Secretary and the National Treasurer of every political party shall, after the issue to it of a final certificate of registration, submit to the Commission a written declaration giving details of all funds and other assets of the political party and the name of the person or firm appointed by the political party as its auditor as set out respectively, in forms EF01 and EF02 in the Schedule.

2. (1) The National Secretary or General Secretary and the National Treasurer of every political party shall submit to the Commission, a written statement, on oath, made by virtue of the Statutory Declaration Act, 1835, giving details of—

- (a) all assets and liabilities of the political party, within twenty-one days after the notification of the holding of a public election which the party intends to contest; and
- (b) all assets, liabilities, income and expenditure incurred either by the party or a candidate put up or supported by the political party specifying the manner in which the expenditure occurred, within sixty days after the declaration of the results of a public election which the party had participated,
