1. Prayers were read by Mr. Alimamy Lincoln-Bangura (Table Clerk).

2 Amendment of Order Paper:

The Majority Leader, Hon. Mathew S. Nyuma, from Kenema District moved a motion to amend the Order Paper by amending the text on item IV (Laying of Paper) to be read "Constitutional Instrument No. 5 of 2024" instead of "Constitutional Instrument No. 1 of 2024." He also moved a motion to expunge item V (Bill: The Industrial Relations and Trade Union Act 2023). The motion was seconded by Hon. Bashiru Silikie from Bo District and approved by the House.

3. Adoption of the Record of Votes and Proceedings for Wednesday 27th March, 2024: The motion for the adoption of the Record of Votes and Proceedings for Wednesday 27th March, 2024 was moved by Hon. Joseph Williams-Lamin from Bo District. It was seconded by Hon. Nenneh Lebbie from Bo District and adopted by the House

4. Laying of Paper:

The Table Clerk, **Mr. Alimamy Lincoln-Bangura** called upon the Attorney-General and Minister of Justice to lay the paper as itemized on the Order Paper.

The Attorney-General and Minister of Justice, **Mohamed Lamin Tarawalley Esq** laid the following paper:

Proclamation by His Excellency Rtd. Brig. Julius Maada Bio, President of the Republic, Supreme Head of State and Grand Commander of the Order of the Republic, Commander-in-Chief of the Armed Forces, Fountain Head of Unity, Honour, Freedom and Justice.

Constitutional Instrument No. 5 of 2024.

Statement by the Majority Leader:

The Majority Leader and Leader of Government Business, **Hon. Mathew S. Nyuma**, thanked the Members of the Opposition for their support in proposing a declaration of a State of Emergency on the drug known as "Kush." He stated that the House was in unison in making the said proposal. For the attention of the Attorney-General and Minister of Justice, he referred the House to Section 29 (5) of the Constitution of Sierra Leone (Act No. 6) of 1991. He stated that the House did not want people to misuse the State of Emergency.





The Attorney-General and Minister of Justice responded by reminding the House about the Covid-19 Regulation that was passed by the House. He said that they were anticipating that in the future, if there is any issue of similar nature, there would be a time saving as they would just recourse to one of the regulations that had been passed by the House. He reminded the House about "The National Drug Control Act, 2008" together with the regulation known as The National Drug for Arrest and Seizure."

Statement by the Acting Minority Leader:

The Acting Minority Leader, **Hon. Daniel B. Koroma**, stated that the Members of the Opposition were in full support of the process. He said that he didn't think it was expedient to use a regulation that had been made pursuant to an act of Parliament for a particular institution to operate and use that same regulation for a state of emergency. He advised that the House should not be lazy, and that if they were declaring a state of emergency. He noted that before the operation of every state of emergency, there must be a regulation of every state of emergency, there must be a tribunal of which The Chief Justice must appoint the Chairman, and the Bar Association must appoint two legal practitioners of not less than fifteen years standing. He appealed for the tribunal to be constituted before the operation. He asked that The Attorney-General and Minister of Justice should go and do a regulation for the said State of Emergency.

Mr. Speaker's Response:

The Speaker, **Hon. Segepoh S. Thomas**, admonished The Attorney-General and Minister of Justice to yield to the submissions made by both leaders as that was expedient. He stated that the fundamental issue of the State of Emergency was due process. He urged The Attorney-General and Minister of Justice to do a regulation in connection with the said State of Emergency.

Hon. Bashiru Silikie rose on SO 41 and read the content of the provision. He advised Hon. Members as well as The Attorney-General and Minister of Justice to resume their seats when Mr. Speaker was addressing the House. He also advised The The Attorney-General and Minister of Justice to do a regulation for the said proclamation made by the President as it was the needful thing to do.

Hon. Aaron Aruna Koroma admonished The Minister to do the regulation as it was expedient for the President to achieve the goal of the said State of Emergency.





5. Standing Order 23 (Personal Explanation):

Hon. Amara M. Kargbo from **Western Rural District** stood on SO 23 and informed the House about a proposition by the Minister of Fisheries and Marine Resources to close down the entire artisanal fishing sector of the country for a month.

Mr. Speaker's Response:

The Speaker, **Hon. Segepoh S. Thomas**, advised **Hon. Amara M. Kargbo** to write a letter to the Chairperson of the Committee on Fisheries and Marine Resources, and copy the Speaker, Deputy Speaker, Majority Leader, Minority Leader, and Clerk of Parliament so it would be discussed at Committee level.

Standing Order 34 (Raising of Point of Order):

Hon. Alpha Fodie Madie Jabbie from **Falaba District**, rose on SO 34 and informed the House that for the past days, **Hon. Abdul Karim Kamara from Kambia District** had been on social media as well as the mainstream media making some outrageous allegations against The Ministry of Basic and Senior School Education (MBSSE) in connection with the West African Senior School Certificate Examinations (WASSCE). He highlighted the said allegations as thus: (1) that the whole Kambia District, not a single candidate would take the 2023/2024 WASSCE; (2) that 80% of schools in Bombali District would not take the 2023/2024 WASSCE. He said that those statements were false and baseless. He clarified that 4, 668 candidates had been registered from 36 schools in Kambia District. He clarified that 65 out of 83 Senior Schools of which 12, 280 candidates had been registered in Bombali District by WAEC. He went on to clarify the allegation that majority of the schools affected were in the northern region. He noted that 146,179 candidates had been registered for the WASSCE. He informed the House about the total and active involvement of the Minister of Basic and Senior School Education as one of the allegations stated that the said Minister was not doing anything to settle the issue. He finally explained the reason why Ghana Porter was still open while the porter of Sierra Leone had been closed.

The Deputy Leader II of Opposition, **Hon. Aaron Aruna Koroma**, noted that the issue was so important that the House should invite the Minister of Basic and Senior School Education to make a statement in connection with said issue.

Hon. Mohamed Bangura from Karene District stated that the issue was very important, and that since Mr. Speaker had given **Hon. Alpha Fodie Madie Jabbie** the opportunity to address the House on the said issue, Mr. Speaker should also give **Hon. Abdul Karim Kamara** a similar opportunity to do likewise in the next adjourned date.





Hon. Rosaline Hawa Siafa from Kailahun District reminded the House about the Free Quality Education which was the flagship program of President Bio in his first term. She stated that two wrongs could not make rights. She pleaded with the House to talk to Mr. President and The Minister of Basic and senior School Education for the West Africa Examination Council (WAEC) to reopen its porter. She asked that the House should punish the school authorities (the headmasters, Principals or boards of schools) instead of the pupils as it had been their habit of sabotaging the Government.

Mr. Speaker's Response:

The Speaker, **Hon. Segepoh S. Thomas**, referred the House to Standing Order 14 (J). He informed the House that the Minister of Basic and Senior School Education would be invited to the House on the next adjourned date to give a statement in connection with the said issue. He stated that the issue was extremely important, and that he was so passionate about it. He directed the Clerk-at-the Table to write a formal letter of invitation to the Minister of Basic and Senior School Education to be in the chamber on the next adjourned date to make a statement in connection with the said issue.

The Acting Leader of Opposition, **Hon. Daniel B. Koroma**, agreed with all the previous speaker on the said issue more especially **Hon. Rosaline Hawa Siafa** who had shown a nationalistic beliefs on the said issue. He believed that education was still the flagship program of the government. He added that the Speaker **(Hon. Segepoh S. Thomas)** whom he believed had extreme value for education would not allow even ten pupils to fail to take their NPSE, BECE or WASSCE due to the negligence of the headmasters, principals or boards of schools.

Mr. Speaker's Ruling:

The Speaker, **Hon. Segepoh S. Thomas**, stated that if the Minister came and informed the House that the headmasters or principals or boards of schools were responsible for the said issue, the House would ensure that their salaries would be seized for a certain number of months.

Adjournment:

Mr. Speaker adjourned the House to Tuesday 16th April, 2024 at 10:00 a.m. The House rose at 11:50 a.m.
