Mr. Speaker stated that as Chairman of Selection Committee when names of Hon. Members would be put forward for the positions of Chairmen for Sessional Select Committees, Hon. Members that would be punctual for sittings would be considered.

Mr. Speaker also informed the House about the sudden death of **Hon. Peter Musa Moigua** from **Kenema District** whose demise took place on Wednesday 7<sup>th</sup> May, 2025. He asked the House to rise up and observe a minute's silence for the deceased. He recited the following prayers as quoted: "May his gentle soul rest in perfect peace."

**Submission by Hon Abdul Karim Kamara:**

The Whip of the Opposition (**Hon Abdul Karim Kamara**) informed the House that on the very day that the late Hon. Peter Musa Moigua had the attack that led to his death, three other Hon. Members were struggling with their health. He stated that the House should not shy away from talking about the things affected Hon. Members. He reminded the House about health challenges that **Hon. Ibrahim Aziz Bangura, Hon. Habib Keifa Fabbah** et al. He emotionally and emphatically stated that the state should take care of the Health insurance of Hon. Members in the course of rendering their services to the people of Sierra Leone. He observed that Hon. Members had been spending every little penny they had to take care of their people in terms of school fees, building roads Bondo society, college fees, building schools etc. He reminded the House that in 2025 alone, three PCMPs had been replaced due to death. He

**Hon. Massay Ngahiteh Uruno from Bo District** totally agreed with the submission made by **Hon Abdul Karim Kamara**. She informed the House that she was once a victim of such condition during an official trip as she encountered an attack, and she noted that had it not been the help from **President Julius Maada Bio**, it would have been different story by then. She informed the House that she was admitted in Choithrams for two days of which the admission fees was NLe 7,000 without any other medication. She finally noted that the House needed to treat the health issues of Hon. Members seriously.

**Submission by Hon. Nenneh Lebbie:**

To start with the Hon. Nenneh Lebbie from Bo District thank Mr. speaker for given her the opportunity to add are voice to the matter of Health issue for Members of Parliament. She then explained her own sad experience she faced when they traveled to Rwanda .She got an attack and they rush her to a hospital and introduced her has Member of Parliament from Sierra Leone and the Doctor ask her for medical Insurance and she shameful said she does not have it and the Doctor ask her again are you sure you are a Member of Parliament and again she shameful answered yes but we had not received it yet. On that note she said she is saying this for there people who taught all is well with them has Members of Parliament.

**Submission By The Leader of Government Business (Hon. Mathew Sahr Nyuma):**

The Leader started by saying he knows Members are all emotional because of the present situation they are faced with. And he further says that he want to use there emotion to say thank you to the President of the Republic and thank you to the Minister of Health that under their leadership they had saved Members of Parliament in Several Health issues. Especially the President and he also refers to a particular member of which was faced with a crucial health issue but by the intervention of the President was easily solved and he is witness of that. And also mention the Leader of the Opposition and so many other Members of Parliament. He further told Members of Parliament that the difficulties they faced with has Members of Parliament regarding Health issues did not started in the Fifth and Sixth Parliament but since the existence of parliament so let them not make it political. He also thank Mr. President again saying that if you want to ask for more you should show sign of appreciation for what has be done. He called to the attention of Mr. Speaker that of all what he had said that more need to be done because there is still difficulties to addressed the Health of Members of Parliament because when an Member of Parliament requested for Health facilities it will take a time before it is done. So they had to make an appeal through the good office of Mr. Speaker to the Government so that they wiii see how handle this difficulties they are going through in terms of Health issues.

**Mr. Speaker Response:**

The Rt. Hon. He further says there is certain percentage in that provision that is given to them and even staffs of Parliament that they should benefited from.
