Mr. Speaker put the question for vote as quoted:

“All those in favor, say Aye.”

“All those against, say Nay.”

Through collection of voices, Mr. Speaker declared that the Ayes had it.

The Table Clerk, **Mr. Alimamy Lincoln**, pronounced that **“the Government Motion by the Minister of Transports and Aviation had been ratified.”**
