The motion was seconded by **Hon. Alpha Babatunde Lewally (Const. 104 – Western Urban Dist.)**.

QUESTION PUT AND AGREED TO

The motion was unanimously carried.

VII. STANDING ORDER 23-

1. **Hon. Hassan A. Sesay (Const. 059 – Tonkolili Dist.)** – Raised concern over the gruesome accident that took place on the 19th April, 20¹⁷, at the Lumley roundabout close to the Police Station. The Hon. Member stated that such accidents usually occur at that same spot, with especially heavily loaded trucks plying the route from Spur road to Lumley. He reminded the House that there is a law that prohibits such trucks but this keeps happening right in front of the Police station, claiming the lives of innocent Sierra Leoneans. He called on the Police Complaint Board to investigate the matter and also for Parliament to summon the Police to explain reason for such incident.
2. **Hon. Alhassan Kamara (Const. 096 – Western Urban Dist.)** – Supported the concern raised by Hon. Hassan A. Kamara and added that the Road Safety Authority should also be included among the parties to be summoned in Parliament because of the lack of road signs that prohibit the use of trucks to ply route of high risk to accident, especially that of Spur road to Lumley.
3. **Hon. Daudu J.B. Kallon (Const. 093 – Western Rural Dist.)** – reminded the House that the Civil and Voter Registration exercise is facing serious challenges in his constituency and he called on the authorities concerned to look into the matter and take the necessary action.
4. **Hon. Alhaji S. Dumbuya (Const. 049 – Port Loko Dist.)** – reminded the House of an announcement he made during the last sitting of Parliament, that he would be organizing a charity and Quran reading in respect of his late mother, who passed away two years ago. The Hon. Member furthered that the ceremony would take place on Sunday, 23rd April, 2017, at
