

PC Alhaji Musa Bamba Foray Kulio Jalloh III**) had been declared by him as a duly elected Member of Parliament of the Republic of Sierra Leone:

Pursuant to Section 83 and the Third Schedule of the Constitution of Sierra Leone 1991 (Act No 6 of 1991) in tandem with SO 1 A (1) of the Standing Orders of the Parliament of Sierra Leone, The Rt. Hon. Speaker, **Segepoh Solomon Thomas**, called upon the Clerk of Parliament to administer the oath of office as enshrined in the Third Schedule of the 1991 Constitution of Sierra Leone.
