1. Prayers were read by Mrs. Fatmata Bintu Weston (Senior Table Clerk).

2. Amendment of Order Paper:

The Acting Leader of Government Business, **Hon. Bashiru Silikie**, moved a motion to amend the Order Paper by changing the initial date from Monday 27th November 2023 to Tuesday 28th November 2023. The motion was seconded by **Hon. Joseph Williams-Lamin** of **Bo District** and approved by the House.

2. Adoption of the Record of Votes and Proceedings for Friday 24th November, 2023:

The motion for the adoption of the Record of Votes and Proceedings for Friday 24th November, 2023 was moved by **Hon. Joseph Williams-Lamin of Bo District.** It was seconded by **Hon. Alice Kornya Sandy of Kenema District** and adopted by the House as amended.

4. Mr. Speaker's Announcement:

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, informed the House about the attempted coup d'état that took place on Sunday 26th November 2023. He also informed the House that some servicemen lost their lives during the course of their duty, and that some sustained serious injuries. He asked the House to observe a minute of silence for those that lost their lives and prayed for a speedy recovery for those that sustained serious injuries. He recited the following prayers as quoted: "May the souls of the faithful departed rest in perfect peace."

Statement by the Majority Leader as well as Leader of Government Business:

The Majority Leader and Leader of Government Business, **Hon. Mathew S. Nyuma**, referred the House to Section 5 (2) b of the Constitution of Sierra Leone (Act No. 6 of 1991) and recited the said provision as quoted:

"The security, peace and welfare of the people of Sierra Leone shall be the primary purpose and responsibility of Government, and to this end it shall be the duty of the Armed Forces, the Police, Public Officers and all security agents to protect and safeguard the people of Sierra Leone." He said that in the spirit of the 1991 Constitution of Sierra Leone, the House must condemn all act of violence perpetrated by the assailants that invaded the military armory on Sunday 26th November 2023. He assured the House that they would support the Government with any legislation to maintain the peace and stability of Sierra Leone. He noted that the fundamental difference between humans and chimpanzees was the rule of law. He registered his disappointment over political leaders on both sides of the aisle that had failed to condemn the said act.





Statement by the Minority Leader of Leader of Opposition:

The Minority Leader, **Hon. Abdul Kargbo**, joined The Majority Leader to condemn the act of violence that was perpetrated during the attempted coup d'etat. He stated that the said actions were very undemocratic. He noted that as a responsible political opposition (APC), the only way that they believed to come to power was through democratic means. He furthered that they would join the Government to ensure that full investigation be carried out as soon as possible. He assured the House of their commitment to a speedy investigation so that those who were responsible would be brought to account.

Mr. Speaker's Admonishment:

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, admonished both the Majority Leader and Minority Leader to crystalize the cross-party agreement that had been expressed on the issue so that the House would speak with one voice, and that their collective message would be conveyed to the Government as a dedicated support. He, thereby, called upon both Leaders to consult with him.

Standing Order 25 – (Notice of Motions):

The Majority Leader, **Hon. Mathew S. Nyuma,** rose on S.O. 25 (1) and gave a notice of motion for the Parliamentary Committees on Defence and Internal Affairs to conduct investigation on the said incident that took place on Sunday 26th November 2023 and bring out their findings within a specific time.

Mr. Speaker stood down the House at 11:05 p.m. The House resumed at 11:15 p.m.

5. Bill: The Appropriation Act, 2024 by The Minister of Finance.

"Being An Act to Authorize Expenditure from the Consolidated Fund for the Services of Sierra Leone for the Year 2024 and for Other Related Matters."

Second Reading:

The Deputy Minister II of Finance, **Mr. Bockarie Kalokoh**, was in attendance, but he was later replaced by the Deputy Minister I of Finance (**Mrs. Jeneba Kpaka Bangura**).

The motion was seconded by **Hon. Joseph Williams-Lamin of Bo District** and approved by the House.

8. Private Member's Motion

Proposer: Hon. Mathew S. Nyuma

Seconder: Hon. Abdul Kargbo

The Majority Leader, **Hon. Mathew S. Nyuma**, moved the motion with the following words as quoted:

"Be it resolved: That this Honourable House of Parliament, following the attempted coup d' etat that took place in Freetown on Sunday 26th November 2023, including in particular the violent attacks at the Military installations at Wilberforce and Murray Town Barracks, the Correctional Centres at Pademba Road and Jomo Kenyatta Road, and various Police Stations in Western Area by some unknown persons, hereby unanimously and unequivocally condemns such illegal acts in their entirety and demands that the Government institute an immediate investigation into the matter with a view to hold accountable all those who are found to be culpable." The motion was seconded by the Minority Leader and Leader of Opposition, Hon. Abdul Kargbo.

Mr. Speaker put the question for vote.

"All those in favor, say Aye."

"All those against, say Nay."

Through collection of voices, Mr. Speaker declared that the Ayes had it.





The Table Clerk, **Mr. Alimamy Lincoln-Bangura**, pronounced that the Private Member's Motion had been carried.
