**1. Regulation of Procedure and Sittings in Parliament:**

Pursuant to Section 94 (1) of the Constitution of Sierra Leone (Act No. 6 of 1991) as stated: **"Subject to the provisions of this Constitution, Parliament may regulate its own procedure, and may in particular make, amend and revoke Standing Orders for the orderly conduct of its own proceedings."** in tandem with the proviso of Standing Order 5 (1) as stated: **"Provided that a sitting on Saturday or Sunday or Monday or a public holiday may be secured by resolution of Parliament moved by a Member at the commencement of public business at a sitting of Parliament,"** The Leader of Government Business, **Hon. Mathew S. Nyuma of Kenema District**, thereby moved a motion for the House to have a resolution to proceed on that day's sitting (Monday 31<sup>st</sup> July 2023). The motion was seconded by the Chief Whip (**Hon. Dickson M. Rogers of Pujehun District**) and approved by the House.

**2. Prayers were read by Mr. Alimamy Lincoln-Bangura (Table Clerk).**

**Mr. Speaker stood down the House at 10:30 am.  
The House resumed at 11:00 am.**

**Proceedings Continued.**

**3. Bill: The Supplementary Appropriation Act, 2023 by The Minister of Finance.**

- i. The Table Clerk, **Mr. Prince Oviasuyi**, called upon the Minister of Finance to proceed with the **Introduction and First Reading** of the bill.

**Introduction and First Reading:**

The Minister of Finance, **Mr. Ahmed Sheku Fantamadi Bangura**, moved that the bill entitled **"The Supplementary Appropriation Act, 2023"** be read the **First Time**.

**Mr. Speaker put the question for vote.**

**"All those in favour, say Aye"**

**"All those against, say Nay"**

**Through the collection of voices, Mr. Speaker declared that the Ayes had it.**

The Table Clerk, **Mr. Prince Oviasuyi**, pronounced that the bill had been read the **First Time**.

- ii. The Table Clerk, **Mr. Prince Oviasuyi**, called upon The Minister of Finance to proceed with the **Second Reading** of the bill.

**Second Reading:**

The Minister of Finance, **Mr. Sheku Ahmed Fantamadi Bangura**, moved that the bill entitled "**The Supplementary Appropriation Act, 2023**" be read the **Second Time**. He presented the objects and reasons of the bill and again moved that the bill be read the **Second Time**.

Mr. Speaker proposed the question for debate:

**Mr. Speaker's Admonishment:**

Before the commencement of the debate, the Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, referred the House to S.O. 69 (3) and recited the aforementioned provision as quoted: "**The debate on the Second Reading of the Supplementary Appropriation Bill shall be strictly confined to the matters for which additional expenditure has been provided, and when the question thereon has been agreed to, the Bill shall not be committed, unless the House on Motion so commits for discussion that schedule, if any, to the Bill, which incorporates expenditure for which Supplementary (contingencies) Warrants have not been issued, and the question "that the Bill be now read a third time" shall be put forthwith without amendment or debate.**" He advised Hon. Members that the debate should be restricted to the issues for which the supplementary budget has been sought by the Minister of Finance.

The Leader of Government Business, **Hon. Mathew S. Nyuma of Kenema District**, pleaded with Mr. Speaker to permit the Minister of Finance to lay the Budget Estimates that ought to have been laid on the Table of the House before the Supplementary Appropriation Bill should have been introduced as stated by S.O. 69 (1) and (4).

**Mr. Speaker's Response:**

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, granted the Minister of Finance the permission to lay the Supplementary Estimates.

**4. Laying of Paper:**

The Minister of Finance, **Mr. Sheku Ahmed Fantamadi Bangura** laid the following paper:

**The Supplementary Appropriation Act, 2023 and The Financial Year 2023 Supplementary Current and Recurrent Estimates.**

**Mr. Speaker's Admonishment:**

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, admonished the Minister of Finance that in future, the laying of paper should first precede the reading of the budget statement.

**Mr. Speaker's Statement:**

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, informed the House especially the new Members of Parliament that there are three arms of government of which are (the Legislature, Executive and Judiciary). He stated that Parliament as one of the arms of government had enormous powers especially the power of the purse. He said that the Executive arm had no money except the one given to them by Parliament, and that had been a fundamental principle. He stated the following powers of the legislative arm of government: the power to legislate; the power to oversee the executive arm; the power to give money and the power of representation. He urged Hon. Members not to minimize the powers that had been given to them by the 1991 Constitution of Sierra Leone. He reminded the House about "The Parliament Act, 2023" that was passed into law as it sought to implement provisions of the 1991 Constitution to the House. He referred the House to Section 74 (4) of the Constitution of Sierra Leone (Act No. 6 of 1991). He stated that Parliament had the power to approve its own budget first before approving the Annual Budget, but they had never done so, but with the Parliament Act, 2023, they would start doing that in the forthcoming year. He noted that it was not for the executive to give money to Parliament but rather for Parliament to allocate money to itself for its smooth running as contained in Section 74 (4). He referred the House to Section 118 (7) of the 1991 Constitution of Sierra Leone and recited the aforementioned provision as quoted: **"Parliament shall be notified by the appropriate Minister or authority of all gifts, donations, grants and pledges made to the State of Sierra Leone."** He drew the attention of all ministers especially the ones that were in the Chamber to the said provision. He forewarned the Minister of Finance that starting from the forthcoming year, the budget of Parliament must first be negotiated before the annual budget. He said that Parliament would not go around begging from the executive instead the executive should do so because Parliament had the money and that Parliament provided the executive with the provisions to run the state and the government.

**5. Suspension of Standing Order 5(2) at 12:00 p.m.**

The motion for the suspension of S.O. 5(2) at 12 noon was moved by the Chief Whip (**Hon. Dickson M. Rogers of Pujehun District**) for the proceedings to continue during lunch. The motion was seconded by the Deputy Chief Whip 2 (**Hon. Ibrahim Tawa Conteh of Western Urban District**) and approved by the House.
