Mr. Speaker's Response:

The Rt. Hon. Speaker, **Segepoh Solomon Thomas**, thanked **Hon. Mariama Munia Zombo** for the notice that she had given to introduce a Private Member's Bill entitled: **The Prohibition of Child Marriage Act, 2024**. He stated that it was the right of Hon. Members to introduce bills as it was clearly provided in Sections 105, 106 of the Constitution of Sierra Leone (Act No. 6 of 1991). He stated that the authority to make laws was vested in the House of Parliament as provided in the aforementioned Constitution. He observed that in other countries, it was their Members of Parliament that made the laws. He advised Hon. Members that they did not need to wait on the Executive to introduce laws into Parliament. He assured **Hon. Mariama Munia Zombo** of his approval and advised her to formally do the needful. He finally noted that when a Hon. Member succeeded in introducing a very powerful bill, that bill would go down in history against that Member's name.

8. Standing Order 25 (Notice of Motions):

The Majority Leader and Leader of Government Business, **Hon. Mathew S. Nyuma**, from **Kenema District** rose on SO 25 and gave a notice of motion for a ruling to be given on the interpretation of Standing Order 77 that has to do with absenteeism. He assured the House of doing the needful.
