### 3. Amendment of Order Paper:

The Leader of Government Business, Hon. Sahr Mathew Nyuma of Constituency 019, Kenema District moved a motion to amend the Order Paper by replacing the seconder of the Motion of the Committee on Appointments and the Public Service, Hon. Hassan A. Sesay of Constituency 050, Tonkolili District, with Hon.Bashiru Silikie of Constituency 082, Bo District. The motion was seconded by Hon. Joseph Williams-Lamin of Constituency 081, Bo District and approved by the House.

### 4. Adoption of The Record of Votes and Proceedings for Tuesday 15<sup>TH</sup> November, 2022:

The motion for the adoption of the Record of Votes and Proceedings for Tuesday 15<sup>th</sup> November, 2022 was moved by **Hon. Hindolo Tennyson Sandy** *of* **Constituency 120, Western Urban District**. It was seconded by *Hon. Alieu Ibrahim Kamara* of Constituency 122, Western **Urban District** and adopted by the House.

### 5. Mr. Speaker's Announcement:

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, reminded the House about the late start of proceedings. He said that he had been cajoling and advising Hon. Members for their prompt attendance, but it seemed that it had been falling into deaf hears. He reminded Hon. Members about the thirty--day absenteeism rule as well as his powers as prescribed by the 1991 Constitution of Sierra Leone together with the Standing Orders of Parliament. He reminded the House that the Votes and Proceedings up till then had only been recording "Hon. Members that were present", and "Hon. Members that were absent with excuse" as a result of the pandemic as it was directed by him. He, therefore, directed the Table Clerks that the Votes and Proceedings should henceforth start recording "Hon. Members that were present", "Hon. Members that were absent," and "Hon. Members that were absent with excuses." as there would be consequences for those who would be absent without excuse.

- (i) The National Council for Civic Education and Democracy Act, 2022 by The Minister of Planning and Economic Development.

The Table Clerk, **Mr. Francis Ernest Farma**, called upon the Minister of Planning and Economic Development to proceed with the Second Reading of the bill.

### **Second Reading:**

The Minister of Planning and Economic Development, **Dr. Francis Mustapha Kaikai**, moved that the bill entitled: **"The National Council for Civic Education and Democracy Act, 2022"** be read the Second Time.
