1. Prayers were read by Mr. Alimamy Lincoln Bangura (Table Clerk).

2. Suspension of Standing Order 5(2):

The motion for the suspension of S.O. 5(2) at 11:15 am was moved by **Hon. Alusine Kanneh of Constituency 013, Kenema District.** The motion was seconded by **Hon. Alice Jebbeh Kumabeh of Constituency 092, Bonthe District** and approved by the House.

Announcement by the Clerk of Parliament:

The Clerk of Parliament, **Hon. Paran Umar Tarawally**, informed the House that he had a very important message for all Hon. Members. He, therefore, urged all Hon. Members to meet him in his office immediately after that day's sitting.

3. Adoption of Record of Votes and Proceedings for Thursday 1st December, 2022:

The motion for the adoption of the Record of Votes and Proceedings for **Thursday 1st December, 2022** was moved by **Hon. Alieu Ibrahim Kamara of Constituency 122, Western Urban District.** It was seconded by **Hon. Mohamed Billoh Shaw of Constituency 039, Falaba District** and adopted by the House as amended.

4. Adoption of Record of Votes and Proceedings for Friday 2nd December, 2022:

The motion for the adoption of the Record of Votes and Proceedings for Friday 2nd December, 2022 was moved by Hon. Mohamed Billoh Shaw of Constituency 039, Falaba District. It was seconded by Hon. Zainab Kama Briama of Constituency 010, Kailahun District and adopted by the House as amended.

5. Mr. Speaker's Announcement:

The Rt. Hon Speaker, **Dr. Abass Chernor Bundu,** informed the House about the development that was frighteningly concerning. He said that he was afraid that they would reach a point (unless it was urgently addressed) wherein their sitting fees and all other related expenses associated with the smooth functioning of Parliament would not be met. He reminded the House that the Second Reading of The Appropriation Bill 2023 had been completed, and that the House should move to the Committee of Supply. He stated that he frankly could not see himself authorizing the commencement of the process on the Committee of Supply without being satisfied with the financial situation of Parliament as an arm of government. He charged the Chairman of the Parliamentary Committee on Finance with the responsibility to ensure that his message reached its destination as expeditiously as it could be conveyed. He said that he bore the responsibility to ensure the smooth running of Parliament as an arm of Parliament, and that nobody should dispute that because it was a statutory duty that he bore under the 1991 Constitution of Sierra Leone and the Standing Orders of Parliament.





The Chairman of the Parliamentary Committee on Finance (Hon. Francis A. Kaisamba) responded that Mr. Speaker's message would be communicated accordingly.

In addition to Mr. Speaker's Announcement, **Hon. Ibrahim Tawa Conteh** submitted that Parliament should be treated as a separate and distinct arm of government.

In addition to Mr. Speaker's Announcement, **Hon. Dr. Mark Mahmoud Kalokoh**, submitted that the process of the Committee of Supply that was about to commence should be forestalled until the welfare of Parliament was addressed. He said that Parliament should be treated as an organ of government.

In addition to Mr. Speaker's Announcement, **Hon. Rebecca Yei Kamara**, submitted that the welfare of Hon. Members should be seriously looked into as some of their colleague Hon. Members had been suffering from illnesses that required medical attentions overseas of which they could not foot their bills.

6. Laying of Paper:

The Table Clerk, **Mr. Alimamy Lincoln Bangura**, called upon the Minister of Mines and Mineral Resources to lay the paper that was itemized on the Order Paper:

<u>Committee Stage:</u> The House resolved itself into Committee of the Whole.

The Table Clerk, **Mr. Francis Ernest Farma**, called upon the Minister of Mines and Mineral Resources to proceed with the Committee Stage of the bill.

Before the Chairman of the Legislative Committee presented the report, **Hon. Ibrahim Tawa Conteh**, submitted that it was totally disrespectful to the House that a representative from the agency for which the bill that was about to be discussed was not present.

8. Suspension of Standing Order 5(2) at 12 Noon:

The motion for the suspension of S.O. 5(2) at 12 noon was moved by **Hon. Alusine Kanneh of Constituency 013, Kenema District** for the proceedings to continue during lunch. The motion was seconded by **Hon. Hindolo Tennyson Sandy of Constituency 120, Western Urban District** and approved by the House.





Continued Proceedings

Presentation of Report:

The Chairman of the Legislative Committee, **Hon. Abdul S. Marray Conteh**, presented the Eight Report of the Fifth Session of the Second Republic of Sierra Leone on the bill entitled: **The National Minerals Agency Act**, **2021**.

Mr. Chairman proposed the question for debate.

The debate started, and some amendments were made.

Mr. Speaker stood down the House at 12:15 pm. The House resumed at 12:25 pm.

The proceedings on the Committee Stage continued.

Mr. Speaker adjourned the House for lunch at 2:00 p.m. The House resumed at 3:00 p.m.

9. Suspension of Standing Order 5(2) at 3:00 pm:

The motion for the suspension of S.O. 5(2) at 3:05 pm was moved by **Hon. Nenneh Lebbie of Constituency 086, Bo District** for the proceedings to continue after the said time. The motion was seconded by **Hon. Abdul Latif Sesay of Constituency 075, Port Loko District** and approved by the House.

Continued Proceedings

10. Amendment of Order Paper:

The Leader of Government Business (Hon. Mathew S. Nyuma) moved a motion to amend the Order Paper by incorporating a new sub item b under the main item IV (Laying of Papers). The motion was seconded by Hon. Alhaji Sorieba Turay and approved by the House.

The proceedings on the Committee Stage continued.

Mr. Chairman put the question for vote. "All those in favour, say Aye." "All those against, say Nay."

Through collection of voices, Mr. Chairman declared that the Ayes had it.

The Table Clerk, **Mr. Francis Ernest Farma**, pronounced that the noted Parts and Clauses had formed part of the bill as amended.

The House resumed from the Committee Stage.

Report Stage:

The Minister of Mines and Mineral Resources, **Mr. Timothy Kabba**, reported to the House that the bill entitled: **"The National Minerals Agency Act, 2022**." had gone through the Committee of the Whole House with some amendments made.

Third Reading:

The Minister of Mines and Mineral Resources, **Mr. Timothy Kabba**, moved that the bill be read the Third Time and passed into law.

Mr._Speaker put the question for vote. "All those in favour, say Aye." "All those against, say Nay."

Through collection of voices, Mr. Speaker declared that the Ayes had it.

The Table Clerk, **Mr. Francis Ernest Farma**, pronounced that the bill entitled: **"The National Minerals Agency Act, 2022**." had been read the Third Time and passed into law.
