






### Standing Order 34 – (Raising of Point of Order):

#### Mr. Speaker's Felicitations:

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, extended his felicitations to the newly approved presidential nominees and wished them well in their respective appointments.

9. Standing Order 23 (Personal Explanations):

The following Hon. Members stood on S.O. 23:

(i) Hon. Ishmail S. Sandy of Constituency 080, Bo District, informed the House about a Sierra Leonean Lady by the name of Federica Ifouma Oruche whose death was reported on 18<sup>th</sup> of October, 2021 in Dr. Shuman Hospital at Pultney Street in Freetown. He also informed the House that a post mortem was done on the body of the deceased on the 27<sup>th</sup> of October, 2021 and that the cause of her death was due to the following reasons: fracture, strangulation, injuries on her body, blunted face and suffering from severe physical assaults upon which the autopsy result was contrary to the cause of death stated by Dr. Shuman Hospital. He pleaded with Mr. Speaker and especially the Chairman of the Parliamentary Committee on Health to engage authorities to investigate further and ascertain the cause of death.

# Standing Order 34 – (Raising of Point of Order):

The Leader of Government Business (Hon. Mathew S. Nyuma of Constituency 019, Kenema District) moved a motion that the Parliamentary Committees on Health and Human Rights should conduct a parliamentary investigation on the said case and report to the House within fourteen days. The motion was seconded by Hon. Hindolo Moiwo Gevao of Constituency 003, Kailahun District and approved by the House.

### Mr. Speaker's Response:

The Rt. Hon. Speaker, **Dr. Abass Chernor Bundu**, ordered the Parliamentary Committee on Health and the Parliamentary Committee on Human Rights to investigate the said issue and report to the House within a period of two weeks.





(ii) Hon. Rebecca Yei Kamara of Constituency 029, Kono District, informed the House about the donation of 200 books and bags to children in her constituency that had taken the NPSE and BECE examinations of which the bags that she had given them were made in Sierra Leone. She, therefore, encouraged her colleagues Hon. Members to be using local cloth to produce bags when they would like to give donations to schools.

She further informed the House about the issue of kidnapping and ritual murdering that had been on the increase in the country.
