- 1. Prayers were read by Mrs. Fatmata Bintu Weston (Table Clerk).
- Suspension of Standing Order 5(2) at 10:25 a.m.
 Hon. Dickson M. Rogers of Constituency 100, Pujehun District moved a motion for the suspension of S.O. 5(2) at 10:25 a.m. for the commencement of proceedings. The motion was seconded by Hon. Moses Baimba Jorkie of Constituency 091, Bonthe District and approved by the House.
- 3. The Adoption of The Record of Votes and Proceedings for Friday 19th November, 2021: The motion for the adoption of the Record of Votes and Proceedings for Friday 19th November, 2021 was moved by Hon. Moses Baimba Jorkie of Constituency 091, Bonthe District. It was seconded by Hon. Ishmael Sama Sandy of Constituency 080, Bo Distict and adopted by the House.

4. Mr. Speaker's Announcement:

The Acting Speaker, **Hon. Segepoh Solomon Thomas**, reminded the House that he had ruled a few weeks ago that a joint Committee on Trade and Industry, Finance and Transparency be constituted to look into the concern raised by **Hon. Ibrahim Tawa Conteh** on some agreements that were ratified by the House wherein some waivers on agreements were done.

The Chairman on Transparency Committee, **Hon. Dickson M. Rogers,** confirmed to the House that they had indeed invited the companies involved to a meeting but the General Managers of the respective companies were out of the jurisdiction of Sierra Leone. He assured the House that upon their return, they would be summoned again and the meeting would be held upon which the Committee would report to the House as so dearly needed.

The Acting Leader of Government Business, **Hon. Bashiru Silikie of Constituency 082**, **Bo District** advised that the Chairman of the Transparency Committee should invoke Section 93 sub-sections (3) and (6)(a) of the Constitution of Sierra Leone (Act No. 6 of 1991) to summon those companies and to enforce their attendance.

Hon. Mohamed Bangura of Constituency 066, Karene District also reminded the House that Mr. Speaker had ruled on the concern he raised few weeks ago about the Sierra Leoneans that had stranded in Germany.

Mr. Speaker's Response:

The Acting Speaker, **Hon. Segepoh S. Thomas,** requested that the Hon. Member should write a letter to the Chairman of the Committee of Foreign Affairs and the Chairman of the Committee on Internal Affairs on the issue.





The Leader of the Opposition (Hon. Chernor R.M. Bah of Constituency 126, Western Urban) informed the House that he had also forwarded a Question to the Minister of Development and Economic Planning through the office of the Clerk and those Questions were yet to have seen the light of day. He pleaded that the rulings of Mr. Speaker should be respected because the rulings of the Speaker should be law.

He also vented his disappointment about the poor attendance of his colleague Hon. Members of Parliament. He said that the Chamber was empty, and that it was an embarrassment for them to invite Ministries, Departments and Agencies (MDAs) while Hon. Members themselves were not in full attendance.

The Acting Leader of Government Business (Hon. Bashiru Silikie of Constituency 082, Bo District) agreed with the Leader of Opposition and added that it was the responsibility of Hon. Members of Parliament to attend Parliamentary sittings but that MDAs should not use that as an excuse for not witnessing the Parliamentary sittings on the budgetary debate of "The Appropriation Act, 2022." He further requested that Parliament should summon all Permanent Secretaries so that they could listen to the concerns raised by Hon. Members about their various Ministries.

Mr. Speaker's Response:

The Acting Speaker, **Hon. Segepoh S. Thomas,** informed the House that the first allotted day of the debate was a grace period. He ruled that the allocations to some MDAs would not be considered by the House if they failed to witness the Second and Third Allotted Day of the budgetary debate on **"The Appropriation Act, 2022."**

5. Bill: The Appropriation Act, 2022 by the Minister of Finance. (FIRST ALLOTTED DAY)

Being an Act to authorize expenditure from the Consolidated Fund for the services of Sierra Leone for the year 2022 and for other related matters.

The Table Clerk, **Mr. Ismaila Kabba**, called upon the Minister of Finance to proceed with the **Second Reading of the bill.**

Second Reading:

The Deputy Minister II of Finance, **Mr. Sheku Fantamadi Bangura**, moved that the bill entitled "**The Appropriation Act, 2022**" be read the **Second Time**.





Mr. Speaker proposed the question for debate.

Hon. Francis Amara Kaisamba of Constituency 020, Kenema District rose on S.O. 63(3) and moved a motion for the debate on "The Appropriation Act, 2022" to be shortened to three (3) allotted days instead of five allotted days. The motion was seconded by Hon. Lahai Marah of Constituency 042, Falaba District and approved by the House.
