1. Prayers were read by *Mrs. Fatmata Bintu Weston (Table Clerk)*.

2. **Suspension of S.O. 5 (2):**

The suspension of S.O. 5 (2) at 10:30 a.m. was moved by **Hon. Dickson M. Rogers of Constituency 100, Pujehun District** for the commencement of proceedings. The motion was seconded by **Hon. Alice Jebbeh Kumabeh of Constituency 092, Bonthe District** and approved by the House.

3. **The Adoption of The Record of Votes and Proceedings for Wednesday 15th December, 2021:**
