1. Prayers were read by *Mrs. Fatmata Bintu Weston (Table Clerk)*.

2. **The Adoption of The Record of Votes and Proceedings for Tuesday 14th December, 2021:**

The motion for the adoption of the Record of Votes and Proceedings for **Tuesday 14th December, 2021** was moved by **Hon. Joseph Williams-Lamin of Constituency 081, Bo District**. It was seconded by **Hon. James Ozan Tholley of Constituency 054, Tonkolili District** and adopted by the House with some amendments.

3. **Mr. Speaker's Announcement:**
