2. For the composition of the Board to be nominate by His Excellency the President except:
 - i. for the two Paramount Chiefs: one of whom shall be a female;
 - ii. the head of one of the Civil Society Organizations registered with the Ministry of Economic Development and Sierra Leone Association of Non-Governmental Organizations;
 - iii. and the Commissioner who shall be Secretary to the Board.
3. To removed and replaced by 6 members appointed by His Excellency the President:
 - i. Secretary to the Vice President
 - ii. Financial Secretary
 - iii. Development Secretary
 - iv. Permanent Secretary, Ministry of Local Government
 - v. Chief Social Development Officer
 - vi. Permanent Secretary, Ministry responsible for labour and social security

Question put and agreed to

That Parts I, II and III, Clauses 1 to 10 as amended by the Leader of Government Business: *i.e.*, that in Clause 3 (2), the position of two Paramount Chiefs one of whom shall be a female; Sub paragraph (g) and (h) be retained as part of the Bill; And a new paragraph to be added to read: 6 members to be nominated by His Excellency the President subject to parliamentary approval.

Hon. Dickson M. Rogers of Constituency of 100, Pujehun District moved the suspension of S.O. 5 (2) at 12:00 noon for proceedings to continue during lunch. It was seconded by **Hon. Mohamed Billoh Shaw of Constituency 039, Falaba District** and approved by the House.
