III. SUSPENSION OF STANDING ORDER 5(2) AT 10: 37 A.M.

Hon. Songowa Bundu (Const. 061 – Tonkolili Dist.) moved the suspension of Standing Order 5(2). It was seconded By Hon. Benneh Bangura (Const. 055 – Port Loko Dist.), and unanimously approved by the House.

Hon. Ansumana J. Kaikai – That he had never moved a Parliamentary motion in the House and as far the issues are concerned, he had effectively informed the House earlier that under S.O. 25(2), whatever motion under his name in the House was not mature because it does not carry his signature as stipulated under S.O. 25(2). In that regard he asked Mr. Speaker, under what Standing Order the Parliamentary motion has been placed under his name, because he does not have a motion legitimately as it reads on the Order Paper.

STATEMENT BY MR. SPEAKER

Mr. Speaker reminded Hon. Ansumana J. Kaikai that the motion was going to be moved by Hon. Frederick S. Sourie, who initially gave a notice of motion for Parliament to debate Statutory Instrument No. 115 immediately it was laid, before Hon. Ansumana J. Kaikai "horridly and excitedly" moved a motion to debate the Statutory Instrument. That action was described by the Majority Leader, as being "hijacked". Mr. Speaker also mentioned that the Hon. Member stood on S.O. 31(1) to withdraw his motion but never knew the implication of it as there were dissenting voices. Therefore, the motion was at the moment owned by the House as by removing the previous mover does not kill the motion. Mr. Speaker added by saying "how could a proposer of a motion ask for the withdrawal of that motion which he did not sign". He emphasized that although the motion had been disclaimed and disowned by the Hon. Member, it was still before the House as per S.O. 31(1).

Hon. Ansumana J. Kaikai – Asked the House with the Leave of Mr. Speaker for the Parliamentary motion to be delivered to the Majority Leader of the House and to have the motion in his name or dedicated to him.

Hon. Karifala S. Conteh – Stood on S.O. 25 (1a) MOVED THAT STATUTORY INSTRUMENT NO. 115 OF 2017 PUBLISHED ON THE 13TH JULY 2017 IN THE SUPPLEMENT TO THE SIERRA LEONE GAZETTE VOL. CXLVIII, NO 38 DATED 13TH JULY, 2017 AND LAID ON THE TABLE OF THE HOUSE ON TUESDAY 19TH SEPTEMBER, 2017 BE DEBATED, PURSUANT TO SECTION 170(7)^(C) OF THE CONSTITUTION OF SIERRA LEONE (ACT NO. 6 OF 1991)

STATEMENT BY MR. SPEAKER

That since the motion was with the House and it had been disclaimed by the previous mover, it has now been owned by **Hon.** Karifala **S.** Conteh, as the new mover of the motion. Mr. Speaker added that S.O. 25(1a) does not require a notice as it is one of the exceptions. It reads "NOTICE OF MOTIONS: (1) Unless these Orders otherwise direct, notice shall be given of any motion or amendment which it is proposed to move with the exception of the following:- (a) a motion for the amendment of any motion."

Hon. Foday Rado Yokie – Quoted S.O. 31(2), requesting for an explanation – "A motion which has been withdrawn may be proposed again at any time during the session; but no motion shall be proposed which is the same in substance as any motion which, during the same session, has been resolved in the affirmative or negative".

Hon. Chernor R. M. Bah (Deputy Speaker) – **point of order** – Responded to **Hon. Foday Rado Yokie,** by explaining to him that the motion has not yet been resolved either in the affirmative or the negative as at that moment.

Hon. Alhassan Kamara – Drew the attention of the House to the Statutory Instrument in question that, it was not properly before the House as it did not have an explanatory memorandum of objects and reason attached to it and is not complete as also did not capture Paramount Chief Members of Parliament as was done in the case of the Statutory Instrument No. 13 of 2012. The Hon. Member ended by invoking Section 94(2) of the 1991 Constitution of Sierra Leone (Act No. 6).

Hon. Foday Rado Yokie – Rose on the issue that the word Parliamentarians is inclusive of Paramount Chief MPs and elected MPs and that there is no distinction between them. The Hon. Member emphasized that the object of his debate was on Statutory Instrument No. 115.

Hon. **Jusufu B. Mansaray** – Referred the House to Section 170(7)^(c) of the 1991 Constitution of Sierra Leone (Act No. 6) .

Hon. **Sualiho M. Koroma** – That the Statutory Instrument made a general description of the nomination fees for Members of Parliament.

Mr. Speaker replied that the Statutory Instrument lacks precision.

Hon. Chernor R. M. Bah (Deputy Speaker) – Quoted Section 74(1) of the 1991 Constitution of Sierra Leone (Act No. 6) that there is a clear distinction between an Ordinary Member of Parliament and a Paramount Chief Member of Parliament. The Hon. Member made reference to Statutory Instrument No. 13 of 2012, which clearly separated Paramount Chief Members from elected Members of Parliament. He ended by saying that the first Statutory Instrument No. 115 of 2017, that was sent to the House was accompanied by an explanatory memorandum, whilst the second one was not. Therefore, Statutory Instrument No. 115 of 2017 was not properly before the House.

Hon. Ansumana J. Kaikai – Drew the attention of the House to the point the Deputy Speaker made, which he said left him struggling to stand on Section 74 of the 1991Constitution of Sierra Leone (Act No. 6), on its entirety because in essence it stipulates that Paramount Chief Members of Parliament are Parliamentarians like himself, who sit in the chamber and receive the same allowance and salary he receives. The Hon. Member added that if they are being referred to as Parliamentarians they are qualified to be called members of Parliament. He ended by commenting on the memorandum and

wondered why the motion was put on the Order paper without a memorandum.

VII. RULING BY MR. SPEAKER

Mr. Speaker ruled that the Statutory Instrument No. 115 of 2017 was not properly before the House and was therefore withdrawn considering the facts as stated above by the **Deputy Speaker** and **Hon. Alhassan Kamara**, respectively.

VIII. ANNOUNCEMENT BY THE MAJORITY LEADER, HON. LEONARD S. FOFANAH

Invited Members of Parliament to a pre-legislative meeting on the Joint Venture Agreement between the Ministry of Information and Communications and WTS Media Group Limited.

IX. ANNOUNCEMENT BY THE TABLE CLERK, MR. LAMIN YANSANEH

Reminded Hon. Members that the Legislative Committee would meet on Wednesday, 4th October, 2017, in Committee Room No. One, to scrutinize the Food and Feed Safety Authority Bill 2017.

X. ADJOURNMENT

The House was adjourned to Thursday 5th October, 2017, at 10:00 a.m.
