The Secretary to Cabinet, Mr. John Sumaila was arraigned before the House of Parliament. He was asked by the Rt. Hon. Speaker to explain to the House the reason for the poor attendance of MDAs to witness the debate on the Presidential Address, which was incumbent on MDAs to do, as relevant issues relating to them would be deliberated.

Mr. John Sumaila responded by extending his apologies on behalf of MDAs. He pleaded by suggesting to the House that Parliament should issue a memorandum to that effect to all MDAs in time as some MDAs might not have gotten the information through the radio and television. He noted that MDAs are always willing to attend Parliamentary deliberations of such importance. He assured Parliament that MDAs would attend subsequent proceedings.
