COMMENT BY THE MINORITY LEADER - HON. DR. BERNADETTE LAHAI:

The Minority Leader commented that, although the the Presidential debate which was about to commence is of crutial importance, based on the context of the Ebola outbreak disease, MDAs were not represented in the Chamber. She enquired from the Clerk of Parliament whether announcement was made to the effect as it was a cause for concern, since it is mandatory that MDAs must be always present to listen to the Budget and Presidential debates respectively, both of which served as important reference points for MDAs.

STATEMENT BY THE LEADER OF THE HOUSE AND LEADER OF GOVERNMENT BUSINESS – HON. IBRAHIM R. BUNDU:

As a rejoinder to the issues raised he reminded Members about a Senior Permanent Secretary who was arraigned before Parliament and tendered an apology to the House on behalf of all the MDAs for failing to attend Budget Sittings.

This he said, is a cause for concern and that the House should look for a permanent solution on this matter.

RESPONSE BY THE CLERK OF PARLIAMENT - MR. IBRAHIM SESAY:

Mr. Clerk in responding to the issues raised by the Minority Leader, Hon. Dr. Bernadette Lahai and the Majority Leader, Hon. Ibrahim R. Bundu respectively, disclosed that a letter was sent to MDAs informing them about the Presidential debate commencing on Monday, 26th January, 2015.

STATEMENT BY MR. SPEAKER:

In the light of the foregoing, Mr. Speaker ordered that as from Monday, 26th January, 2015 it is mandatory that whenever there is debate on Budget Speech, Presidential Address, Bills or Agreements, the relevant officials of all MDAs must be present in the Chamber.

Secondly, Mr. Speaker advised Members that undertones should not be overtones, and that even when Members make undertones, they should be suppressed to the point as if nothing is heard.
