The Minister replied to the several points raised and moved for the Bill to be read the second time.

#### **SECOND READING:**

The Bill was read the second time and was unanimously accepted by Members.

## MOTION:

 Hon. Dr Bernadette Lahai - on a point of Order, S.O. 51 - That the Bill be committed to the Legislative Committee for further scrutiny. Seconded by Hon. Ansumana J. Kaikai.

#### **COUNTER MOTION:**

2. Hon. Ibrahim R. Bundu - moved that the House proceed with the Committee Stage.

Seconded by Hon. Mohamed A. Tarawallie.

#### **COMMITTEE STAGE:**

The Bill went through the Committee of the Whole House with the following amendments:

(1) PART VI, Clause 64 - was amended to read as follows:

A Candidate may withdraw his nomination by notice in writing with the endorsement of the Political Party to which he belongs and delivered by him to the Returning Officer......

(2) CLAUSE 69 - A new subsection in Section 69 as subsection(2) to read as follow:

A new subsection in Section 69 as subsection(2) : "National Returning Officer "means the person responsible for the supervision of the elections conducted under this Act. **MOTION**:

(3) Amendments proposed by Hon. Mathew S. Nyuma as to insert a new clause 7496) AS FOLLOWS: - The Electoral Commission shall not supply excess ballot papers more than the number of registered voters in that polling station. He was seconded by Hon. Musa T. Sam.

## COUNTER MOTION:

Hon. Dr Bernadette Lahai - There must be excess but the House must agree on the quantum and that NEC should work on a formular to know the thresholh.

Hon. Mathew S. Nyuma - motion withdrawn.

# **DECISION OF MR SPEAKER**:

That he would consult with NEC on the matter, but suggested 10% of excess ballot papers, but need not be included in the Bill and would be done administratively.

Hon. Musa T. Sam - clause 87 - moved that the following words, "And the polling station staff shall be prosecuted for committing an Electoral offense " after the words Electoral Commission.

# **DECISION OF THE MINISTER:**

That clause 161 subsection 2 takes care of that proposed amendments which reads as follows:

An employee of the Electoral Commission who contravenes subsection (1) and a person who causes that employee to commit the contravention shall each be liable, on summary conviction, to a fine of five hundred thousand leones or to imprisonment for a term of two years.

Hon. Musa T. Sam - still pressed on with his motion. He was seconded by Hon. Mathew S. Nyuma.

# COUNTER MOTION:

By Hon. Alpha Babatunde Lewally - moved that clause 87(1) remain as it was. Seconded by Hon. Chernor R.M. Bah.

# VOTES:

The Nayes were in the majority.

Motion moved by Hon. Musa T. Sam was defeated.

Hon. Sam-May L. Macarthy - CLAUSE 64 - That the words candidate be omitted - was amended by the Minister.

Hon. S.B.B. Dumbuya - on a point of Order – That the proposed amended clause should stay as it was to avoid doubt and ambiguity.

Clause 106 (1) - Hon. Shiaka M.Sama - clarification on the word " personation" - ( Currect Word).

## SUSPENSION OF S.O. 5 (2):

Moved by Hon. Ibrahim R. Bundu, seconded by Hon. Kondeh Y. Conteh and accepted.

#### COMMITTEE STAGE CONTINUED:

Hon. Sam-May L. Macarthy - clause 113 - That clause 113, A,B,C,D and F be expunged, No seconder - (motion lost).

Hon. Ajibola Emanuel Manly-Spain - 113 (a) - moved that the words - Attempt to vote be added after the words votes to read - " Unlawfully votes or attempt to vote". This amendment was accepted by the Minister.

Hon. Frank Kposowa - clause 139 side votes - That 21 days should be the same number of days in page 5 of the Bill and not 7 days.

Hon. Mathew S. Nyuma - clause 137 (7) - That "A decision of the Electoral Offences Court shall not be questioned in any other Court by any means whatsoever" should be read in tandem with section 122(1) of the Constitution of Sierra Leone, Act No 6 of 1991 - That there should be right to appeal pursuant to the principles of National Justice.

# **DECISION OF THE MINISTER:**

Would amend the clause appropriately on the right to appeal and that the right to appeal has not been withdrawn from anybody - and – amended as follows: Any person convicted to the Electoral Offences Court may appeal against such convictions to the High Court.

Hon.Dr Bernadette Lahai - raised question as to whether the Election Offences Court was decentralized.

MINISTER - Replied in the affirmative, that the Court will sit in various locations.

Hon. Ibrahim Sorie - on the issue of time limit.

MINISTER - Within three weeks.

## THIRD READING AND PASSAGE INTO LAW:

The Bill was read the third time and unanimously passed into law with some amendments.
